Mr. Wilkie explained the City will have to match the grant in the 2009 budget, which is what is typically done every year. He added the the full grant available is \$500,000, but typically the City only averages about \$200,000 which leaves the City to match \$100,000.

Mr. Wilkie explained they needed a bridge to cross the Turtle Creek side of the Nettleton Public Schools property. He further explained they projected the cost, but there is a shortfall after bids were taken. He discussed the situation and noted if the trend continues the costs of the project will get higher. He added he wanted to make the committee aware they were hoping to request appropriations from the Finance Committee. Chairman Charles Frierson stated Mr. Wilkie can let the Finance Committee know Public Services discussed it and are in favor of the bridge without commenting on the financing. Councilman Hargis questioned the current status of the greenway. Mr. Wilkie stated there is 2,000 feet of greenway already on Race Street connecting Allen Park to Nettleton Central Elementary School.
