
Dear Donna:

Roger,

Attached is the opinion I am sending this morning to our ROW Dept. in Little Rock. If their approval comes to me, I will forward it to you as soon as I receive it. There is a small section a cable located on the property that would require a minimal Work Order to remove. Generally, the buried portion is abandoned in place, the riser would be unsplice and removed and the pedestals pulled. The owner(s) or developer must agree to reimburse SWBT for those costs. If the buried portion must be removed by SWBT, obviously there would be additional work and cost involved. When this work needs to be done, they should contact the Business Office and initiate a CWOTS order. The CWOTS process takes a couple of weeks, at least, so some time should be allowed before the work is actually needed. If I need to send a copy of the letter to the city or if you need any more information- please feel free to call me.
