Dear Mr. Scott:

Request lot 2 and 4, Block K, Siglers College Addition to Jonesboro, Arkansas be rezoned from R-1 to C-3.

Lot 2 and 4 of Block K, Siglers College Addition is bounded on the West, South, Southeast and Northwest by C-3 property and on the North and Northeast by R-3. Across the 68+5 foot right of way for Stone Street, Block L is R-1.

The property owners of lot 2 and 4, Block K feel it would be consistent for this property to carry the same classification as the balance of same block.

In event the commission rules C-3 as an unsatisfactory classification, then C-4 will be acceptable to the property owners of lots 2 and 4, Block K.
