Mr. Owens explained this resolution is being walked on tonight's agenda because it did not make the agenda deadline due to the Mayor having some questions before it could be approved.

He noted this contract is for \$70,626.98.

Councilwoman Ann Williams asked what portion of the Turtle Creek Greenway this is for. Mr. Owens answered it will run from the northern border of the Turtle Creek Mall property then north along Matthews Avenue for 500 feet. He added this project is paid for by the Arkansas Recreational Trails Grant, which is an 80/20 matching grant. He added the City received another grant called the Bikes Belongs Grant for \$5,000, which is being used as match money for this project. He stated the City's match for this project will be approximately \$9,500.

Councilwoman Williams asked when this project will be completed. Mr. Owens answered once all the procedures are filed he hopes to have it completed by September 23, but the contract will run through October 8.
