RESOLUTION BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS TO ESTABLISH THE JONESBORO PROPERTY MAINTENANCE CODE BOARD OF APPEALS

Sponsors: Mayor's Office

Councilman Street explained due to the upcoming election concerning the Property Maintenance Code he would like to postpone the establishment of the appeals board until the election is finished. He further explained the attorney representing the group petitioning to repeal the code recently sent a letter to the city concerning the code and cited Arkansas State Statutes as support.

Chief Operations Officer LM Duncan stated there was some question about the timeline in which the board has to be appointed after the City Council approved the

code. He added that is why the Mayor wanted to go ahead and move forward with establishing the board and walk the resolution on to the City Council agenda tonight.

Councilman Woods asked for clarification of the legal issues. Councilman Street explained the attorney asked the city to cease and desist until after the election and cited Arkansas Code 14-14-914 (d)(1). The code stipulates that the effective date shall be delayed until the ordinance is ratified by the electors. He noted the election isn't until May 10th.

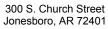
