Craig Light, Director of Engineering, approached the podium, "When we closed the class 4 landfill many years ago, we put a deed restriction on the property that was exactly the same as this one. Unfortunately the legal description didn't include the old class 1 landfill in the class 4 that's above that. When we opened it back up for the tornado damage a couple years ago it came to everyone's attention that we didn't have that deed restriction in place, so that asked that we get this document passed and on record. What we did was have the whole entire boundary of the landfill included in one document, so the entire Strawfloor landfill site has a deed restriction on it."
