Mr. Inboden, who is also an employee of City Water and Light (CWL), thanked the Mayor and City Council on behalf of CWL for the job they do for the City. He then discussed Jonesboro Unlimited (JU) and the Jonesboro Economic Development Corporation (JEDC). He noted JEDC works with the Chamber of Commerce to secure industry for the City. He added JU is a part of JEDC and helps to raise money for JEDC. He stated Jonesboro was one of only six metropolitan areas in the country that saw job growth during the recession. 8. MAYOR'S REPORTS

Mayor Perrin reported on the following items:

He announced he, City Clerk Donna Jackson, Councilman Street and Councilman Fears will be leaving tomorrow for the Municipal League meeting in Hot Springs. He will bring back a full report on what they attend.

They have received the deed for the detention pond behind Walgreens. They will be paying the \$8,000 in back taxes and will be working with CWL to get an interlocal agreement to provide funding for the pond. The pond has already been designed and construction should start within three to four weeks.

They are anticipating the legislative audit to be complete at the end of the month. He has sent a letter asking for Chairwoman Williams to be allowed to attend the meeting.

The City was awarded \$81,900 in Safe Routes to School funding this year. Most of the funds will go towards the Valley View School District. The superintendents of the school districts decide who will get to use the funding. He met with the superintendent from Valley View and will be coming back to Council with recommendations for approval.

The street overlays are complete and there should be no outstanding bills. They are looking for additional overlays.

All of the striping has been completed for this year.

They sent a letter to the Highway Department concerning a right-hand turn lane on Parker Road at the intersection with Highway 226. They are expecting an answer in the next three to four weeks.

They are continuing to hold the public meetings concerning the public tax. They are still getting the word out and yesterday met at St. Bernard's Village. They are going to be visiting several civic clubs to discuss the tax.

They have discussed a central purchasing system for the City. They think funds can be saved by going to a central purchasing system.

As of July 1, a Finance Department employee will be located in the Inspections Department so builders and others purchasing a permit can pay for the permit in Inspections, instead of having to go to City Hall. They are working towards having an online system set up for applying and paying for permits to increase customer service and save time.

Regarding the financial reports, the City is almost \$1.4 million under budget with the Operations and Maintenance Fund. He noted there are still several items that need to be paid for, including the retirement plan.

9. CITY COUNCIL REPORTS

Councilman Street questioned the status of the incinerator. Mayor Perrin stated the incinerator is up and has electricity. The fencing has been ordered and they are hoping to test the incinerator out next week. He added ADEQ will be touring the incinerator after it is up and running.

Councilman Street noted Mayor Perrin was appointed to the Arkansas Good Roads Committee. Mayor Perrin stated the first meeting is next week.

Councilman Woods motioned, seconded by Councilman Moore, to suspend the rules and add RES-10:080 and RES-10:081 to the agenda. All voted aye.
