The party of the first part is the owner of certain property at 417 West Nettleton Avenue, Jonesboro, Arkansas, Parcel Number 17.





The party of the second part has agreed to the following requests made by the party of the first part.

I have appraised the above property as of October 12, 2000, and find the market value to be \$23,688. In accordance with your instructions, I have reduced the lot size by the "amount of taking" for the purpose of widening Nettleton Street. The remaining value is \$22,496 or a difference of \$1,192 which is the just compensation due the owner. In addition, a temporary easement is being used in the amount of 94.527 sq ft. A fee of \$150 is paid for this inconvenience bringing total compensation to \$1,342.

The purpose of this appraisal is to give a fair market value of the land taken by the City of Jonesboro for the expansion of Nettleton Ave. The subject at 417 W Nettleton will lose a tract of land: 744.540 sq ft.

The value of the improvements has not been affected. Therefore, the tax assessed value of \$67,730 has not been used. The set back should not affect the driveway and the entrance to the improvements.

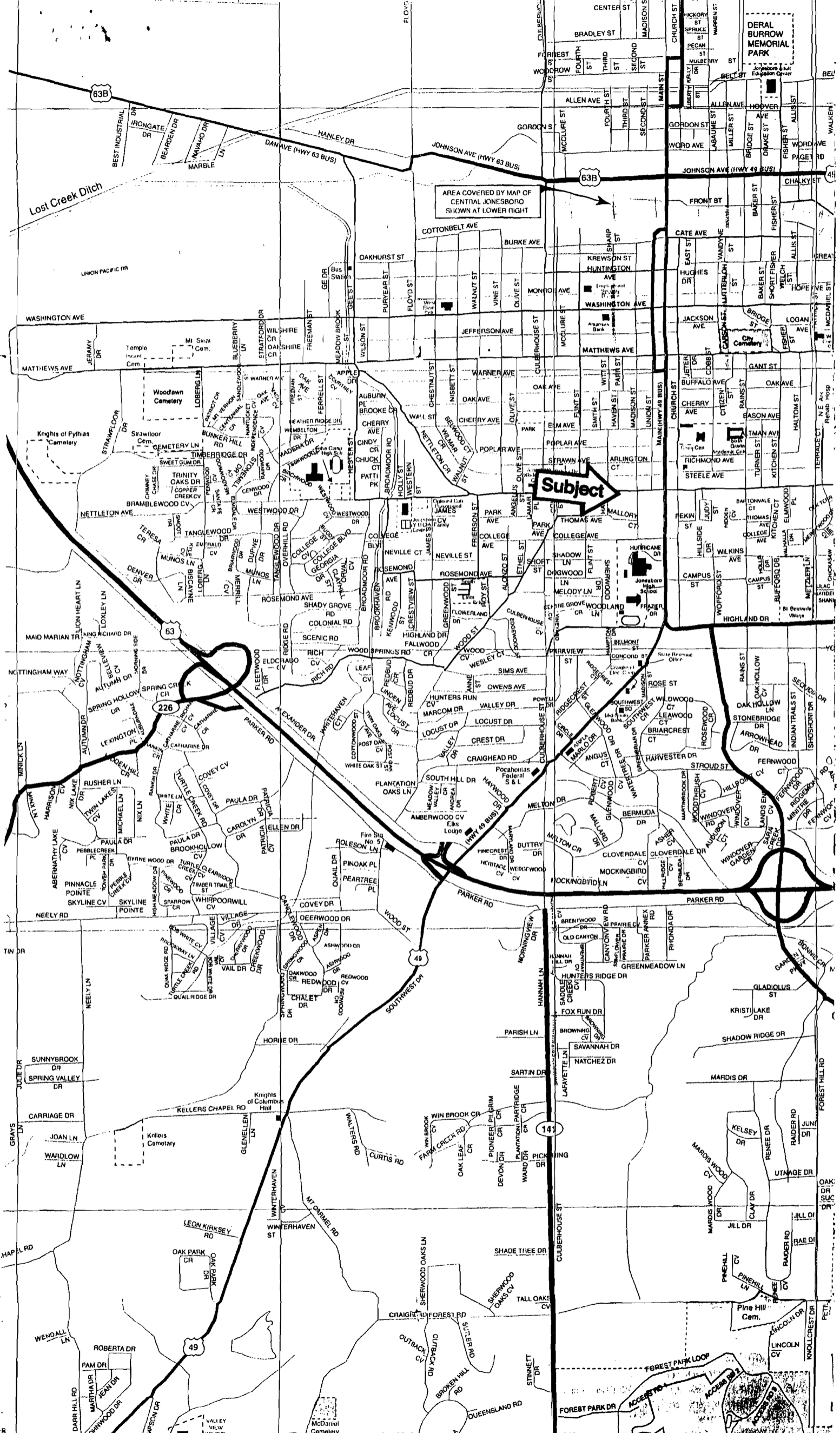

DEFINITION OF MARKET VALUE: The most probable price which a property should bring in a competitive and open market under all conditions requisite to a fair sale, the buyer and seller, each acting prudently, knowledgeably and assuming the price is not affected by undue stimulus. 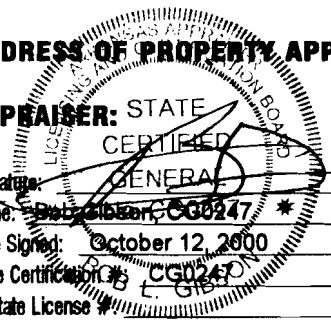

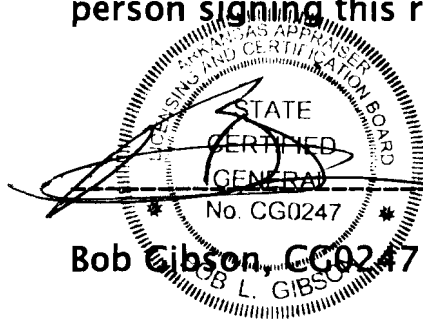
