

WHEREAS, the City currently has the FY2015 50/50 Match Grant with the Arkansas Parks and Tourism Department of \$35,000 for the Craighead Forest Park Trailhead that expires on May 1, 2016; and

WHEREAS, the City had unforeseen events occurred that prohibited the completion of the project by the May 1, 2016; and

WHEREAS, the City requested and was given initial approval for a no-cost extension of the project through December 31, 2016.

SECTION 1: The current grant deadline should be extended through December 31, 2016 for the completion of the Craighead Forest Park Trailhead Project.
