ORDER OF CONFIRMATION OF ANNEXATION

On this date comes on for hearing before this Court the above-styled cause and matter now

appearing for the approval and confirmation of the annexation of lands heretofore dated December 31, 2007. This matter is heard upon pleadings of petitioners Adam Saulsbury and Randi Saulsbury, husband and wife, and Randell Pierce and Diann Pierce, husband and wife, and orders with exhibits

thereto filed herein, the Affidavit of the Circuit Court Clerk of Craighead County, Arkansas,

certifying that no proceedings have been filed to prevent the annexation of said lands and territories

herein, from all of which together with other things and matters before the Court, the Court doth

find:

1. That said lands herein have been annexed to the City of Jonesboro by Order of this

Court dated December 31, 2007, and that no proceedings have been filed in the Circuit Court of the

Western District of Craighead County, Arkansas, to prevent such annexation within thirty (30) days

from the date of said order of annexation, and that said annexation was in all things done in

conformity with the laws and statutes of the State of Arkansas, and should therefore be approved and

confirmed; that said territory should be accepted by the City of Jonesboro; that the lands aud

territories annexed to the City of Jonesboro, Arkansas are more particularly described as follows,

to wit:

Part of the South 463.00 feet of the East Half of the Northeast ¼ of Section 5, T13N-R3E, more particularly described as follows;

Commence at the East ¼ corner of said Section 5; thence North 25.97 feet to the point of beginning; thence continue North 437.03 feet; thence S 88° 03' 00" W 286.65 feet; thence S 03° 58' 00" E 208.72 feet; thence S 88° 03' 00" W 90.28 feet; thence S 01° 21' 00" E 229.17 feet to the North right-of-way of a road; thence N 88° 30'08" E along the North right-of-way of said road 362.72 feet to the point of beginning, containing 3.23 acres, more or less, and subject to highway right-of-way on the East side.

IT IS, THEREFORE, BY THE COURT, CONSIDERED, ORDERED AND ADJUDGED that the annexation of said lands and territory herein to the City of Jonesboro, Arkansas, be and in all things approved and confirmed, and that the proceedings before this Court be and are hereby confirmed. That npon acceptance of the territory by the City Council of Jonesboro, Arkansas the Clerk of this Court shall be and is hereby authorized and directed to certify one (1) copy of the plat of the annexed territory and one (1) copy of the order of the court and the resolution or ordinance of the City of Jonesboro, Arkansas and forward a copy of each document to the Secretary of State who shall file and preserve the same and shall forward one (1) copy of the plat of the annexed territory and one (1) copy of the order of the court to the Director of the Tax Division of the Arkansas Public Service Commission, who shall file and preserve the same and shall notify all utility companies having property in the municipality of the annexation of property, and the Clerk is directed to forward a certified copy of this order to the City of Jonesboro.
