DEDICATION OF RIGHT OF WAY

KNOW ALL MEN BY THESE PRESENTS:

That the Jonesboro Urban Renewal & Housing Authority of Jonesboro, Arkansas, for and in consideration of the sum of One Dollar (\$1.00) and the benefits to accrue thereby, does hereby dedicate to the public use forever for the purposes of street right of way the following described property in the City of Jonesboro, Craighead County, Arkansas, to-wit:

The West 20 feet of Lot 8 in Block 5 of Broadway's Addition to the City of Jonesboro, Arkansas, and a part of Lot 9 of Block 5 of Broadway's Addition to the City of Jonesboro, Arkansas, more particularly described as follows: Begin at the Southwest Corner of said Lot 9 (said point being 140 feet South of the Northwest Corner of Lot 9); thence East 20 feet; thence North 100 feet; thence West 20 feet; thence South 100 feet to the point of beginning; and

A part of Lot 5 in Block 5 of Broadway's Addition to the City of Jonesboro, Arkansas, more particularly described as follows: Begin at the Southeast Corner of said Lot 5, thence West 60.0 feet to the point of beginning proper; thence on a curve to the right having a radius of 25.0 feet a distance of 39.27 feet to a point 40 feet South of the North line of said Lot 5; thence North 40.0 feet to the North line of Lot 5; thence West 20 feet to the West line of Lot 5; thence along the ~~West line of Lot 5~~ a distance of 65 feet to the South line of Lot 5; thence East 45.0 feet to the point of beginning proper.
