Finance Director Jim Barksdale explained two main events have happend to impact JETS' budget. He explained the first event is the City's change to cost accounting, which made each department responsible paying for bills such as unemployment and pension. He stated the total amount JETS needs will be \$69,261 for the rest of 2009, but the amount could go down. He further explained the second event concerned an FTA drawdown. He stated the previous JETS director classified some money as being capital expenditures instead of operational expenditures, which caused problems with FTA. He added when the error was found FTA made JETS repay \$228,000. He noted a second FTA grant was used to pay the \$228,000.
