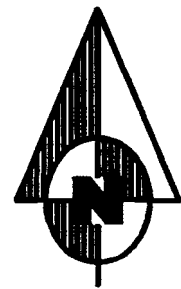

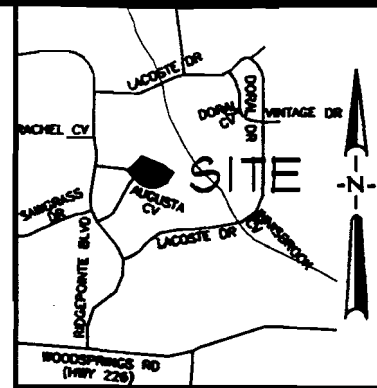


GRAPHIC SCALE

DESCRIPTION

A PART OF LOTS 12 AND 13, BLOCK D, AS SHOWN ON THE PLAT OF RIDGE-POINTE COUNTRY CLUB PHASE I, RECORDED IN PLAT CABINET B AT PAGE 87, CRAIGHEAD COUNTY, ARKANSAS, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID LOT 13, SAID POINT BEING THE POINT OF BEGINNING; THENCE NORTHWESTERLY 10.02 FEET ALONG A CURVE TO THE RIGHT ALONG THE SOUTH- WESTERLY LINE OF SAID LOT 13 TO A POINT, SAID CURVE HAVING A CENTRAL ANGLE OF $02^{\circ}36'31''$ AND A RADIUS OF 220 FEET; THENCE NORTH $35^{\circ}16'56''$ EAST 219.66 FEET TO A POINT ON THE NORTHEASTERLY LINE OF SAID LOT 13; THENCE SOUTH $66^{\circ}37'34''$ EAST 20.44 FEET ALONG THE NORTHEASTERLY LINE OF SAID LOTS 13 AND 12 TO A POINT; THENCE SOUTH $35^{\circ}16'56''$ WEST 224.74 FEET TO A POINT ON THE SOUTHWESTERLY LINE OF SAID LOT 12; THENCE NORTHWESTERLY 10.00 FEET ALONG A CURVE TO THE RIGHT ALONG THE SOUTHWESTERLY LINE OF SAID LOT 12 TO THE POINT OF BEGINNING, SAID CURVE HAVING A CENTRAL ANGLE OF $02^{\circ}36'18''$ AND A RADIUS OF 220 FEET.
