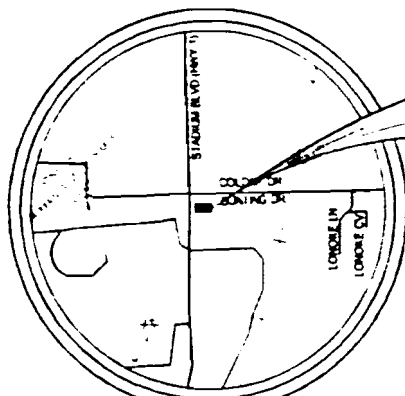
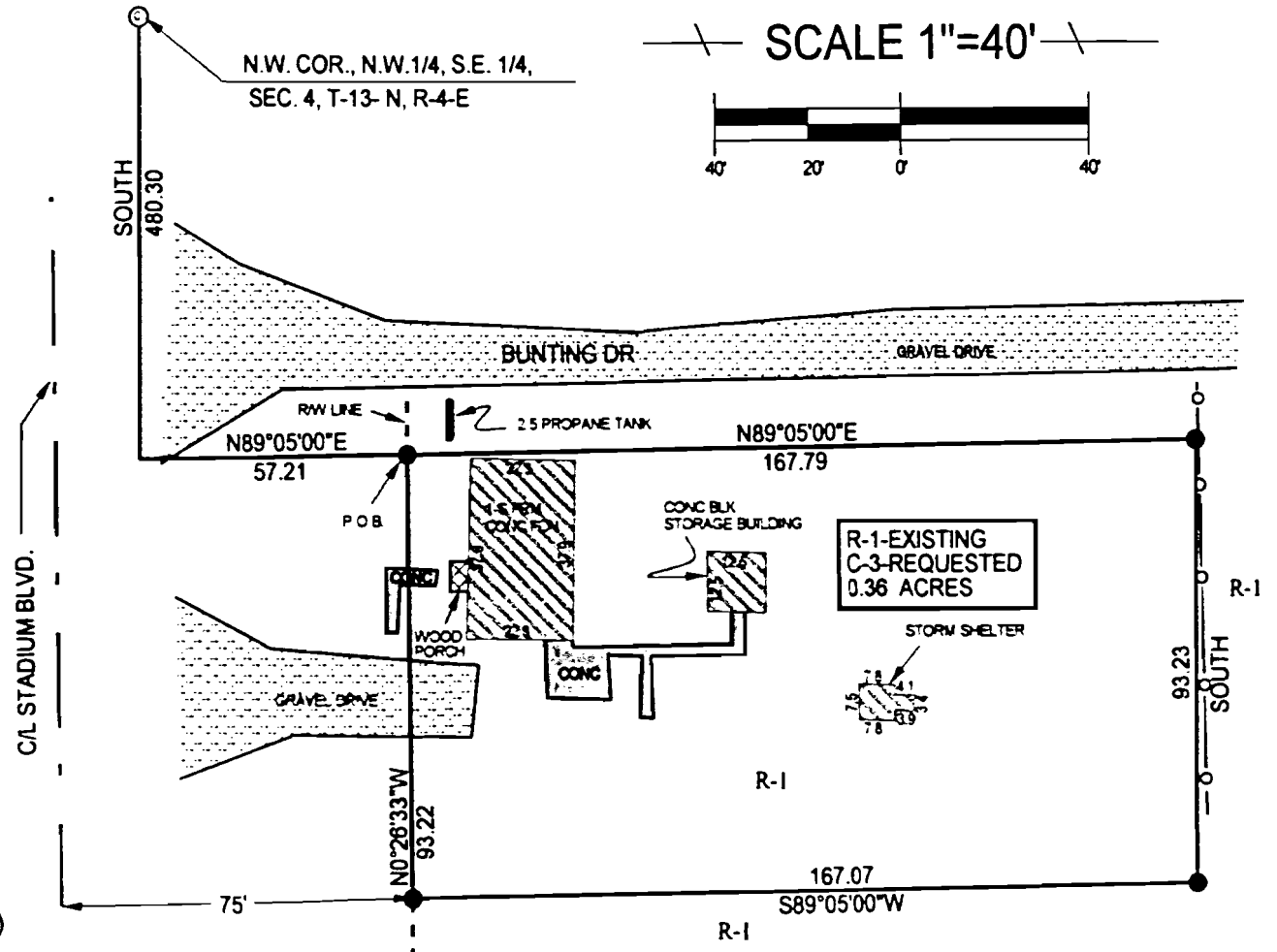


# HENSON'S MINOR PLAT

 BEGIN AT THE NORTHWEST CORNER OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 4, TOWNSHIP 13 NORTH, RANGE 4 EAST, CRAIGHEAD COUNTY, ARKANSAS; THENCE SOUTH ALONG THE WEST LINE OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 4, AFORESAID, 480.30 FEET; THENCE NORTH 89°05'00" EAST 57.21 FEET TO THE EAST RIGHT-OF-WAY LINE OF STADIUM BOULEVARD THE POINT OF BEGINNING PROPER; THENCE CONTINUE NORTH 89°05'00" EAST 167.79 FEET; THENCE SOUTH 93.23 FEET; THENCE SOUTH 89°05'00" WEST 167.07 FEET TO THE EAST RIGHT-OF-WAY LINE OF STADIUM BOULEVARD; THENCE NORTH 0°26'33" WEST ALONG SAID RIGHT-OF-WAY LINE 93.22 FEET TO THE POINT OF BEGINNING PROPER, CONTAINING 0.36 ACRES.

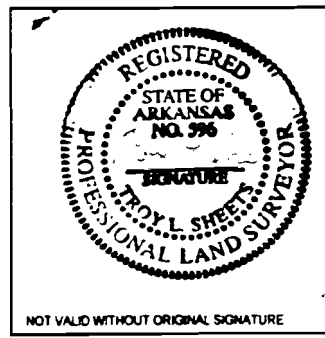
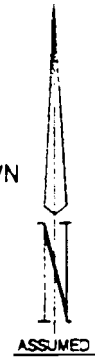
