Mr. Mike Black and Ms. Tawana Bailey from JETS discussed the resolution. Ms. Bailey explained they went with Arkansas Conversion Center since they were the low bidder. She also explained they decided to go with Chevy Uplander vehicles because they hold more riders. Discussion was held concerning the mileage from 2007. Ms. Bailey explained the vehicles are a 83-17 match, in which they will have to cover 17% of the cost. Councilman Frierson questioned the prices for para-transit rides. Ms. Bailey stated they charge \$2 per one way trip. Councilman Hargis noted the December numbers for para-transit ridership dropped in December. Ms. Bailey agreed, stating they attribute the decrease to the holidays which caused doctor's offices to be closed and people who had vacation time off. Councilman Hargis then questioned how many vehicles JETS has. Ms. Bailey stated they have six buses and one para-transit van, as well as a truck for the mechanics and a van to transport drivers. Councilman Frierson questioned how they chose who to send the bid to. Ms. Bailey explained they used Presidential Conversions to purchase the last van and they also had information concerning Arkansas Conversion Center. She added they only sent invitations to bid to those two companies.

Discussion was then held regarding JETS working with other area transit services. Ms.

Bailey explained they have a joint transportation plan with Abilities Unlimited, FOCUS, The Learning Center and St. Bernard's. She further explained they have a joint maintenance plan where if one of the their vehicles breaks down or needs an oil change then they bring the vehicle to JETS and JETS fixes the vehicle.
