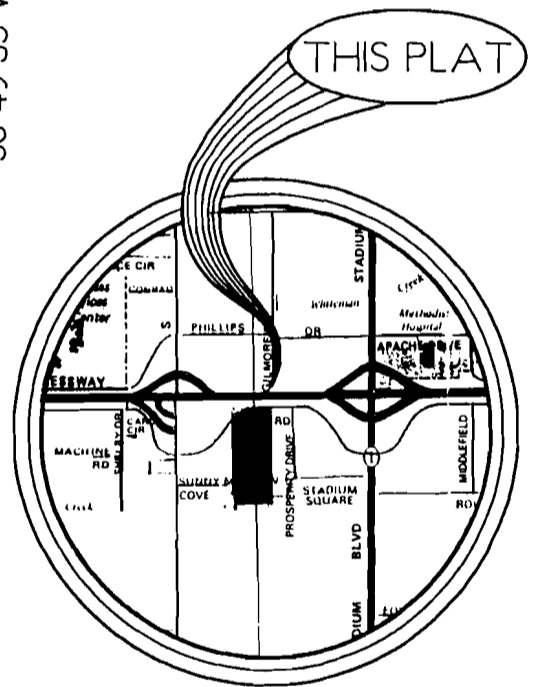
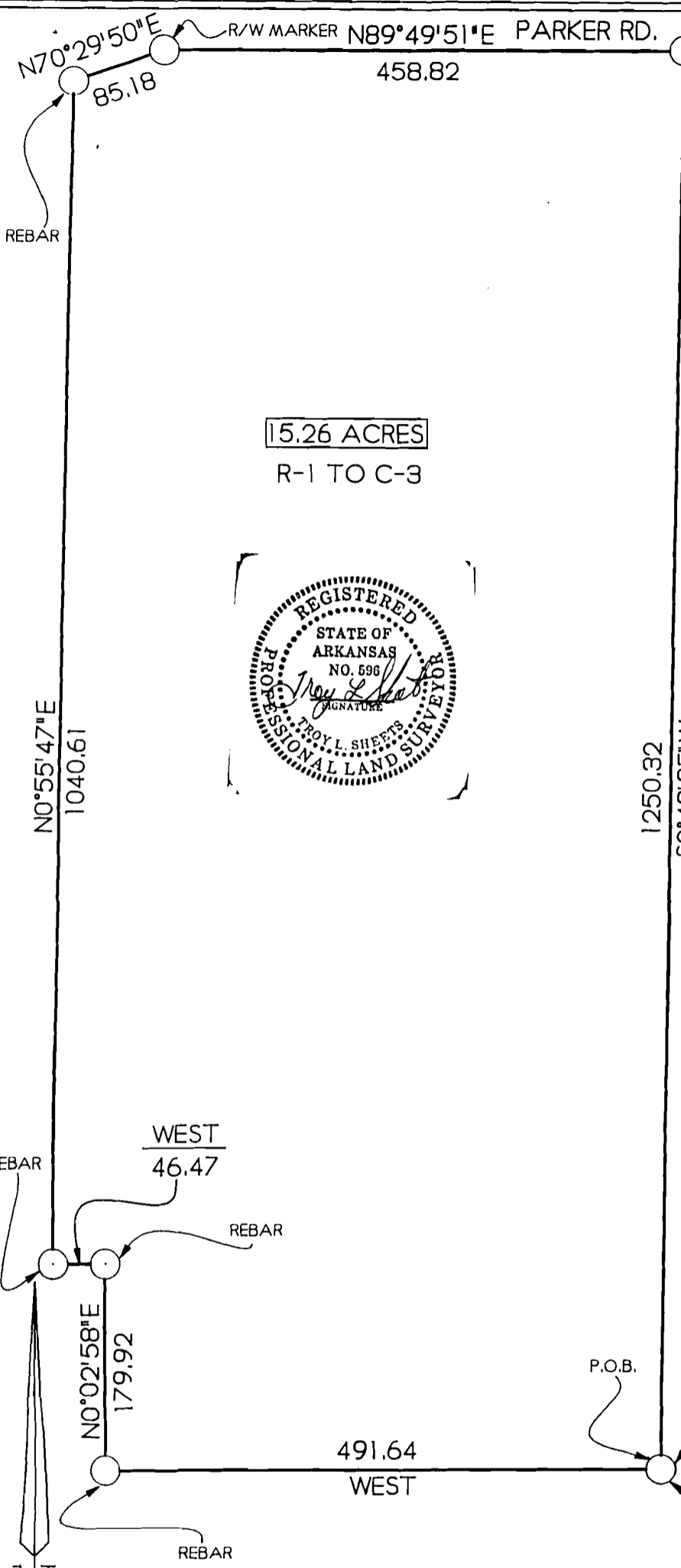
DESCRIPTION

PART OF THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 14 NORTH, RANGE 4 EAST, CRAIGHEAD COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

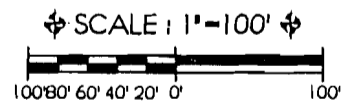
BEGIN AT THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 14 NORTH, RANGE 4 EAST, CRAIGHEAD COUNTY, ARKANSAS; THENCE WEST ALONG THE SOUTH LINE OF THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 33, AFORESAID, 491.64 FEET; THENCE NORTH 0°02'58" EAST 179.92 FEET; THENCE WEST 46.47 FEET; THENCE NORTH 0°55'47" EAST 1040.61 FEET TO THE SOUTH RIGHT-OF-WAY LINE OF PARKER ROAD; THENCE ALONG SAID RIGHT-OF-WAY LINE AS FOLLOWS: NORTH 70°29'50" EAST 85.18 FEET, NORTH 89°49'51" EAST 458.82 FEET TO THE EAST LINE OF THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 33, AFORESAID; THENCE SOUTH 0°49'35" WEST ALONG SAID EAST LINE 1250.32 FEET TO THE POINT OF BEGINNING PROPER, CONTAINING 15.26 ACRES.
