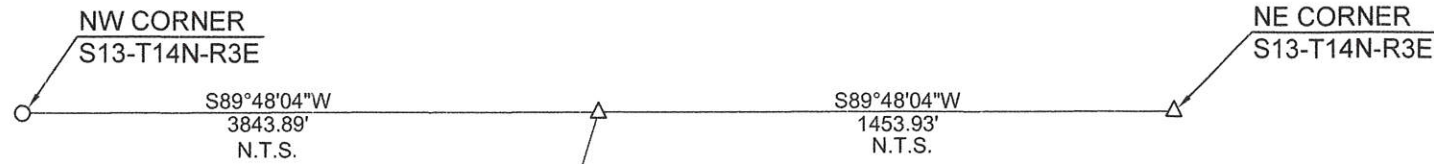
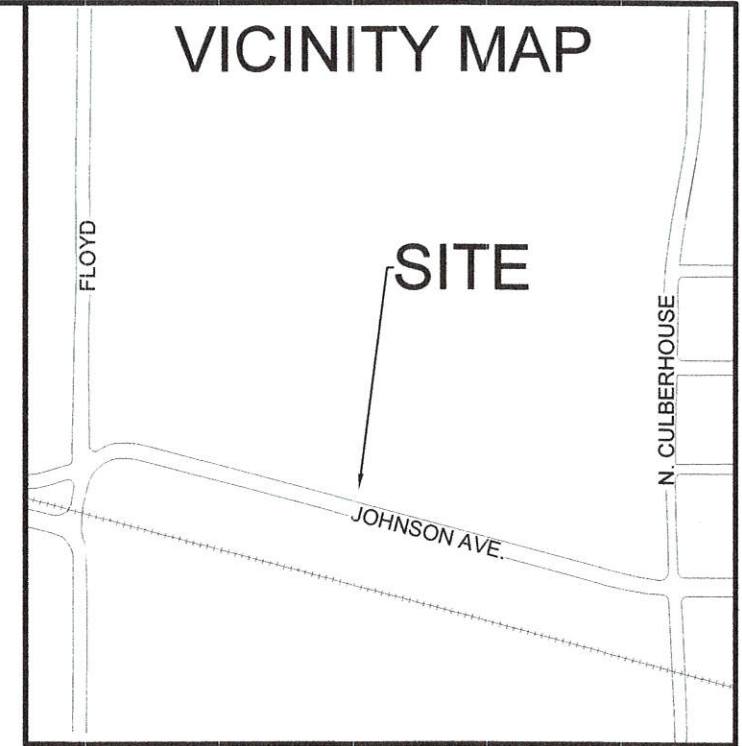


# REZONING PLAT

JONESBORO COORDINATE SYSTEM.



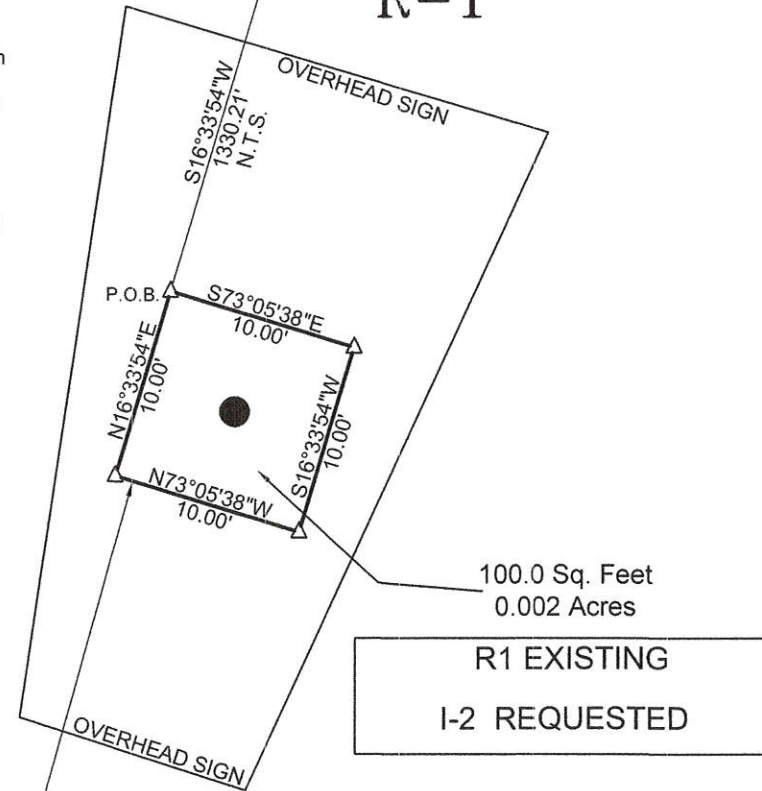
