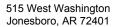

Grants Administrator Heather Clements stated the grant will be for \$27,400. The funding will be used for cameras and toughbooks for police vehicles. Councilman Street expressed concern over the lighting and ease of use of the laptops that are currently in the vehicles. He explained the officers have to pull over to be able to use the laptops because they are not easy to use. Also, the lighting is so bright the officers having trouble using them at night since the lighting allows them to be seen. He noted half of the officers don't use them. Chief Financial Officer Ben Barylske stated the officers want the toughbooks. Councilman Dover then questioned whether the grant is fully funded. Ms. Clements answered yes.
