Ms. Clements stated the City was awarded \$106,400 from Arkansas Service Commission for 16 part-time service members for services to be done in North Jonesboro. She further explained this requires match funds, but the funds will come from the Rockefeller Grant and the 2012 CDBG Action Plan for North Jonesboro, which both have been approved. She noted they are looking at a November 1 start date for the service members.

Councilman Street asked if this is from the Rockefeller Grant. Ms. Clements answered this grant comes from the Arkansas Service Commission through the Department of Human Services. She added the service members will work 850 service hours from November 1, 2012, to September 30, 2013. Discussion was then held concerning the areas the service members will be working.

Chairwoman Ann Williams asked if there will be a cost to the City. Ms. Clements answered no.

# GOVERNMENTS BY THE STATE OF ARKANSAS RELATED TO COLLECTIONS OF LOCAL SALES AND USE TAXES.

Sponsors: Finance

Mike Burroughs explained the City has no way of knowing who is paying sales tax or how much is being paid and this resolution is asking that the State of Arkansas provide that information. He noted the Municipal League recommended this and the Arkansas Government Finance Officers Association also approved it. He added the State is getting 3% of the City's sales tax money and the City wants to know where it is going and how it is being spent.

Councilman Dover asked if the City knows where the sales tax money is coming from or if the City just receives a lump sum without knowing where it comes from. Mr. Burroughs answered the City just receives a lump sum without knowing where the money is coming from.

*Mr.* Burroughs noted this will allow the City to know how much sales tax and who is paying the sales tax into the State from the City's Public Safety tax.

Councilwoman Williams questioned if the City will be able to find out who is getting rebates. Mr. Burroughs answered yes.

*Mr.* Burroughs explained this resolution will allow the City to present this issue to Legislators. Councilman Dover stated this will not change the law. Mr. Burroughs agreed.
