*Councilmember Chris Moore explained as Mr. Hafner pointed out to me, there is an emergency clause on this ordinance. That is because the main blower for the incinerator is out and it is estimated that it will take six to eight weeks from the time that we approve this before we have it. We are about to move into the summer season which is extremely busy out there. Building Maintenance Director Ronnie Shaver explained that the incinerator is over ten years old and with the heat and stuff that has been on that engine, we are lucky that it has lasted this long. We went through the process of trying to get bids on this and there is only one company in town that would give us a turnkey quote. Everybody would sell us parts, but the company we are dealing with would have to be the one to install it. Councilmember John Street stated that since we purchased the incinerator it has saved us a lot of money in tipping fees. It is a valuable asset for the city and all of the citizens that use it. Mayor Copenhaver stated, we are also looking at ways of using alternative fuels for cleaner and more efficient burning.*

*Councilmember Chris Gibson requested that ORD-21:025 be read at three readings.*

*Councilmember Chris Moore's question to the committee was if we could change it to where the council meeting, in case an emergency is declared by the Mayor or the Governor, could be held strictly audio and not the requirement for audio and video as it may be impossible to have video feed at that time. City Attorney Carol Duncan said, what we had discussed, and I'm not sure if it has gone into effect yet, but the Legislature actually passed a bill that speaks to that issue if the Governor declares an emergency. It does not say anything about if the Mayor declares one. So, we would be kind of setting our own rules on if the Mayor declares an emergency. But, the Governor's emergency already accounts for an open public meeting through electronic means, including without limitations, telephone, video conference calls, or video broadcast. But, it does require that the meeting still be open to the public and if it is done by electronic means that there be a way for the public to be present electronically or by telephone and it still has the requirement that those meetings be recorded whether it is a sound only recording, a video recording with sound and picture, or digital or analog broadcast capable of being recorded. So, what it basically did is give the Governor that authority if he declares an emergency. And, maybe the Mayor can speak to this. I think that the theory behind the Mayor having the authority to call an emergency meeting is the idea that we may need to have a special called meeting because of an emergency or declaration of an emergency where one or more councilmembers may not be able to attend in person and giving the Mayor the authority to allow them to appear electronically. The majority of the council would still be present in person, but allowing in case of an emergency, one or two members to appear virtually if needed. I don't know that necessarily accounts for the tornado like we experienced last year. I think the idea of a conference call council meeting is not allowable under FOIA unless there is a way to give public notice and have the public on the call. Which might not be feasible in an emergency situation like you were describing. So, I think what this accomplishes is that it requires you to be seen on camera so the public knows who is voting and how. They can see your face and hear your vote. I think if we get into a situation where we need an emergency meeting, that we need a telephone meeting, then different rules might apply. And, in an emergency situations, you take emergency measures and you have council approve things later. An example of that was after the tornado the stop lights was down and we made a decision to go ahead and get another light put up and the cost of that was something council would need to approve, but because of public health and safety, the Mayor made the decision to go ahead and get that done and then council approved it after the fact. I think there was an Attorney General opinion, we talked about that, I don't have it with me, where a city had done something similar they had made an emergency decision and then later council retroactively approved that emergency expenditure along with an emergency clause and the Attorney General said that was acceptable. It's not preference that it be done, but in a true emergency it was acceptable to do. Councilmember Moore stated that he would yield to the rest of the council.*

*Councilmember Chris Gibson explained that the rest of the changes that were made were simply housekeeping changes, but I would ask that this be held to three readings.*

## **8. MAYOR'S REPORTS**

*Chief Operations Officer Tony Thomas gave the Mayor's Report.*

*Mr. Thomas reported on behalf of Mayor Harold Copenhaver because he needed to attend a funeral visitation service. Mr. Thomas explained that the administration team had met with Lindsey Wingo and the Downtown Jonesboro Alliance group. The Mayor has pledged to make downtown more pedestrian friendly and will soon be announcing some adjustments to how we handle traffic on Main and Union streets. It is rare, but we have had pedestrians struck by vehicles and the Mayor deemed that as unacceptable. So expect at least some measure of change in the upcoming weeks.*

*The city's pool complex opened this past weekend for the summer and lots of people especially youngsters have a lot of pent up energy. The Mayor appreciates the Parks Department and the nearby Fire Department that occasionally gets called over in the case of accidents or emergencies. We appreciate every city staffer who helps provide nice things for the safety and security of our residents.*

*The Jonesboro Police Department has hired ten new police officers that have been hired in the past two weeks. That is bound to be comforting to all of the JPD staff. We do understand that they have worked a significant amount of overtime because of the low numbers of officers. These are difficult times to be a police officer, but the recent track record shows that JPD Officers have handled themselves among some of the*



*best in the nation at a delicate time in our history. We want everyone to know that JPD is here to protect and serve to ensure the safety of Jonesboro. Please support them in every way you can, as well as all of our First Responders. It seems an appropriate time to mention that we are continuing to dedicate overtime for police and our parks system. What we are seeing not just in Jonesboro, but across the country is a degree of aggressiveness as the world transitions out of hopefully what is the worst of a once in a lifetime pandemic in our nation. I think people are better behaved in Jonesboro than in most places. But, everyone is ready to get out and go. We are too. We just have to remember to do it with graciousness and respect for those who worked the hardest during the COVID pandemic and in many cases are working hard to get life back to a normal pace and speed. Please be patient, be thoughtful of your neighbors, be kind to those that are not as comfortable as you are at this point. We are all one community and we can take care of one another.*

*The Northeast Arkansas Mayors Caucus met this morning in Paragould and Mayor Copenhaver was elected as Chair of the Coalition that represents dozens of mayors from seven counties. Walnut Ridge's Mayor Charles Snapp was elected as vice-chair, and Blytheville's Mayor James Sanders was elected as treasurer. We are eager to see what can be done when we all work together for the good of our region.*

*Litter pickups continue to take place on Spring Saturday's and a handful of Neighborhood Associations have joined with our Code Enforcement Officers, Sanitation Crews, and Police Officers to get rid of tons of upon tons of garbage and old items that they no longer want.*

*More than six tons of refuse was collected three weekends ago at the Fisher Street Northside cleanup and we appreciated Dr. Coleman and his efforts in that neighborhood. Weekend before last, the Scenic Hills cleanup resulted in eleven tons of garbage. We also want to thank Judy Casteel for helping lead the Scenic Hills cleanup event. Code Enforcement is busy reaching out to other neighborhood associations because we would like to see these efforts continue. Not only in the areas they currently are in, but other places throughout our city. We are continuing to cleanup Jonesboro. I see it every day and I hope that those in our community are noticing that too.*

*Councilmember Chris Moore asked Mr. Thomas if it is the next council meeting that we are planning to be back to full operation. Mr. Thomas explained that we would be back to business as usual, as it was pre-pandemic. Councilmember Moore said, so we are asking that people that have items on the agenda are welcome to attend those meetings. Mr. Thomas said, correct we are ceasing the call-in line and individuals who wish to attend the meetings may do so without restrictions or limitations at this particular point of time. We look forward to welcoming the public back to fully open chambers. Councilmember Moore asked that Communications Director Bill Campbell to please prepare a press release to that effect. Mr. Thomas said, yes. We can do that and we also know that City Clerk April Leggett always works with us to make sure that is disseminated to the public as well as all of our press partners.*

*Councilmember John Street stated, I just want to second something that Mr. Thomas said. There are a lot of kids out there with the school year coming to a close. They are going to be in the streets, going up and down the sidewalks, and in and out of neighborhoods. It's always a concern for safety in residential areas. So, please be aware of kids who will now be present in the streets and playing. Drive a little slower*

*through the residential neighborhoods and be on alert as we go through the summer.*

*Councilmember Dr. Charles Coleman said he just had one item and that is on June the 19th, we will have another cleanup planned. It will stretch from Fisher Street all the way over to Culberhouse.*
