LEGAL DESCRIPTION

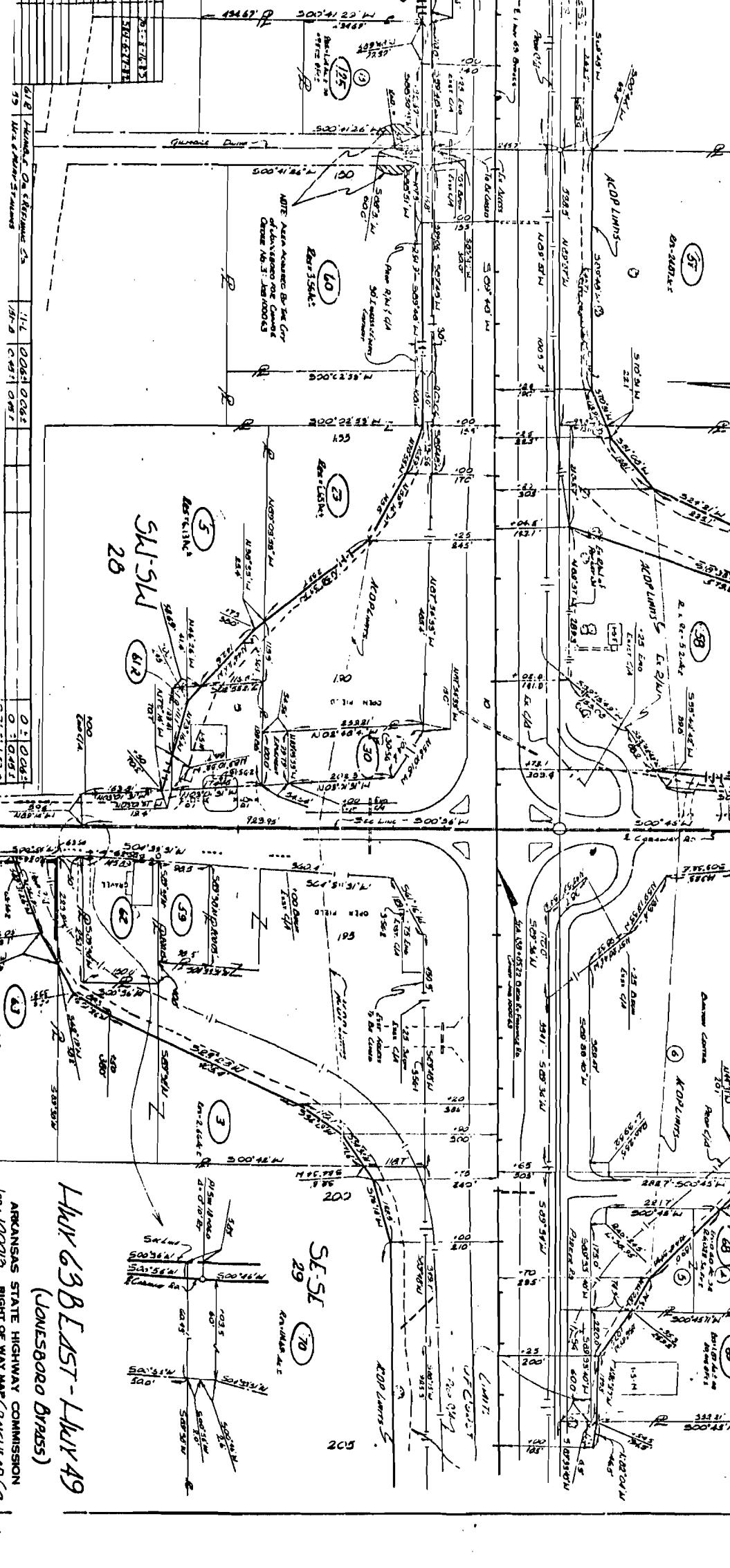
