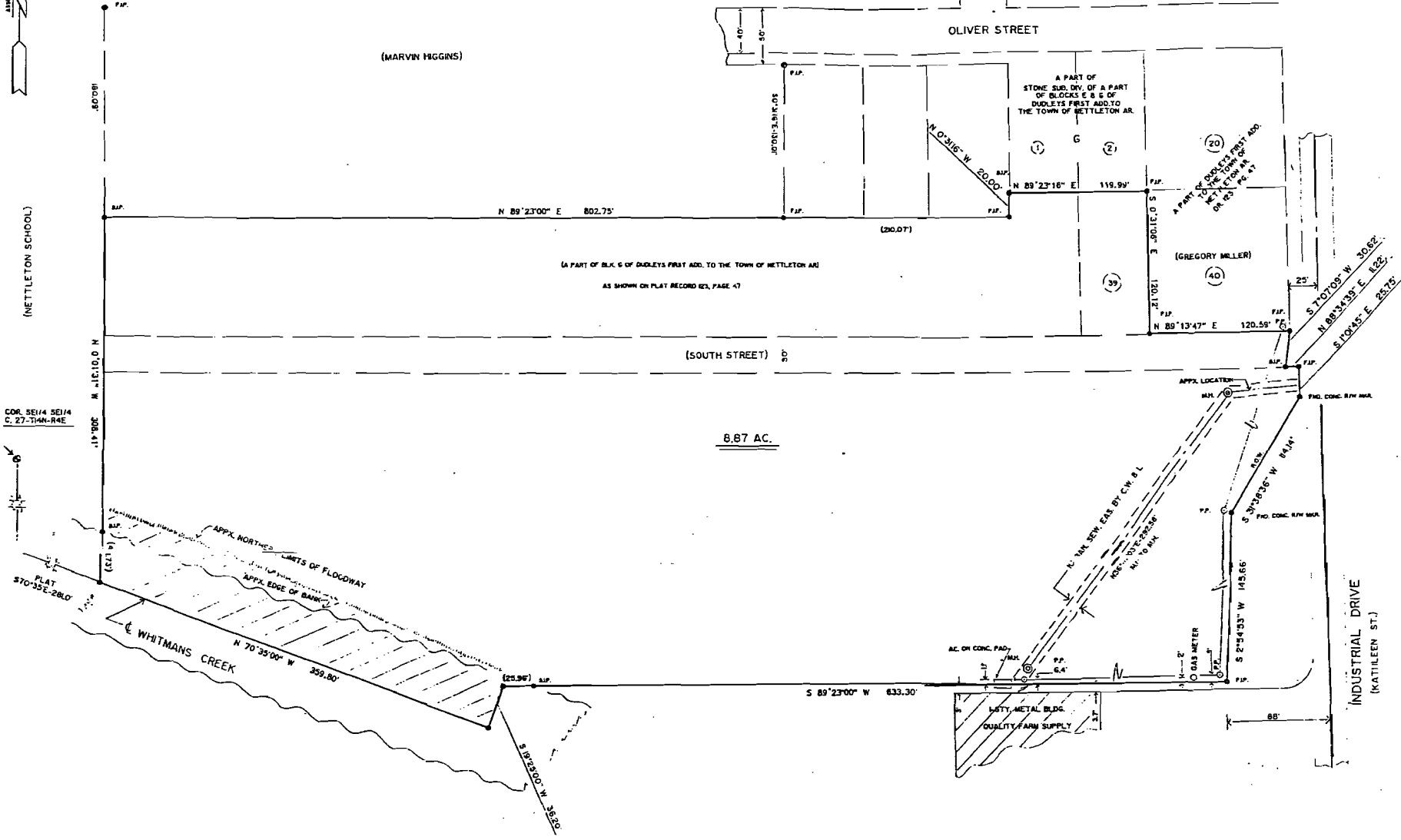
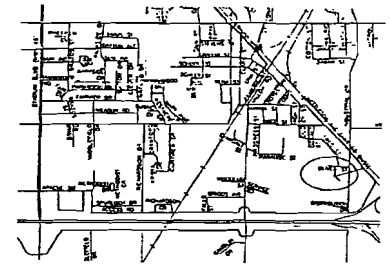

VICINITY MAP

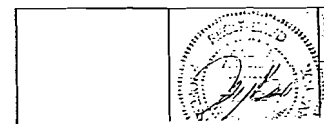

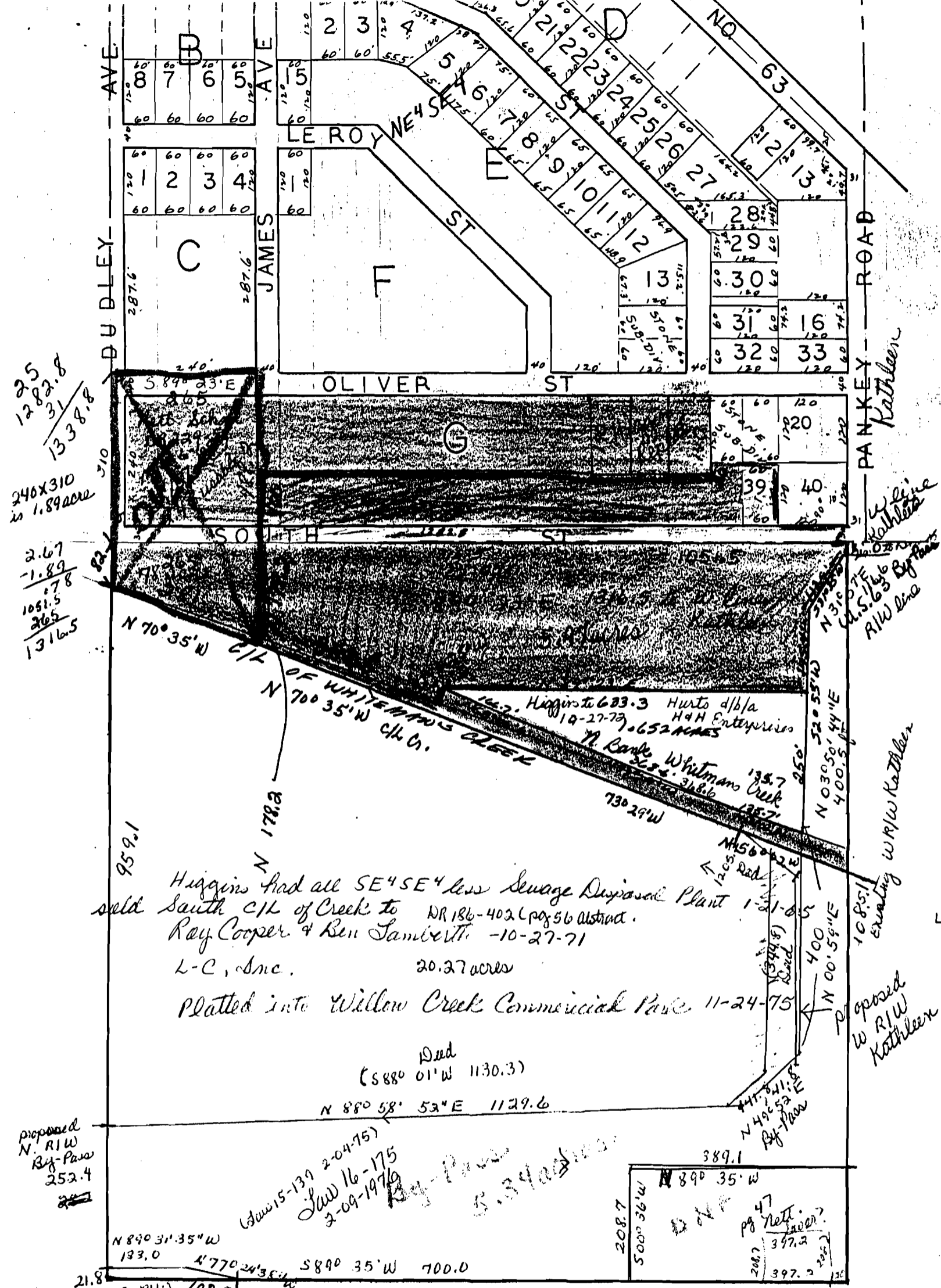
