The above said agreed amount to be paid shall be free and clear of any and all encumbrance with the exception of none.

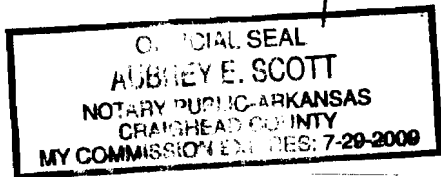

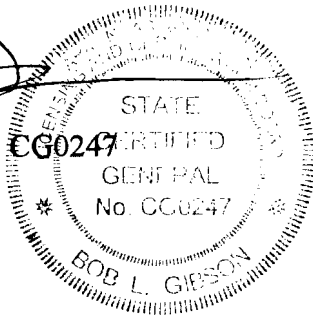
Dear Mr. Scott:

I have appraised the above property as of February 26, 2002, and find the market value to be \$18,000. In accordance with your instructions, I have reduced the lot size by the "amount of taking" for the purpose of widening Nettleton Avenue. The remaining value is \$17,529 or a difference of \$471 which is the just compensation due the owner. In addition, a temporary easement in the amount of 199.73 sq ft is being used. A fee of \$150 is paid for this inconvenience. 1 tree is being destroyed. A fee of \$500 is paid for this loss. \$100 is paid for relocating shrubs bringing total compensation to \$1,221.
