1. Call to order by the Mayor at 6:30 P.M.

Mayor Formon called the meeting to order at 6:30 p.m

2. Pledge of Allegiance and Invocation

Mr. Bruce Burrow of MBC Holdings spoke regarding drainage issues at Turtle Creek, clarifying his remarks were not directed at the Jonesboro City Council but rather to the Administration. Mr. Burrow explained MBC Holdings had been fielding calls from citizens living south of the Mall at Turtle Creek due to comments made at the last city council meeting, held June 19, 2007. He explained the residents wanted to know why MBC Holdings had not lived up to their agreement of resolving flood plain issues, and removing them from the floodplain so they could stop paying higher insurance premiums.

Mr. Burrow explained the City Council approved a six million dollar TIF to help with infrastructure, while the developers and owners of the property purchased their own bonds, resulting in no public funds being expended for the project. Mr. Burrow stated from their research they found no other private entity or firm in the State of Arkansas has taken as many structures out of the flood plain as MBC Holdings, who has spent a total of 7.6 million dollars in drainage and traffic improvements.

Mr. Burrow reported when the project began, the City of Jonesboro was to put in walking and bike trails on the east side along the drainage ditches, however three years later the work has not been done. He also stated MBC holdings acquired nine acres for a retention pond as well as two houses. The purpose for purchase of the homes was to provide a continuation of the walking and bike trails while the other was to provide access to the retention pond. However, the City of Jonesboro inquired about the deeds for the purpose of making an offer to a competition of MBC Holdings. Mr. Burrows stated MBC

Holdings does not deed property to the city to be sold off for something other than its intended use, and in the future any agreement will contain a revisionary clause that the property will revert back to the developer if it is not used, because the City of Jonesboro is not in a position to benefit from a gift.

It was explained that MBC Holdings delivered beyond what was requested, and filed the LOMR, which by MBC Holdings calculations should bring approximately 484 structures out of the flood plain pursuant to the existing maps. He stated on May 25, 2007 FEMA submitted a letter to the City of Jonesboro stating the LOMR had been accepted and would be in effect thirty days from that date, or on June 25, 2007. Mr. Burrow stated he is at a lose as to what to do because the City of Jonesboro refuses to do notification based on some possible future occurrence.

Mr. Burrows contended that Ms. Delamare sent an email to Mr. Tony Thomas advising him not to inform the public of the changes in the flood plain because the developer and the city were aware that the LOMR may be superceded when the new maps come out. Mr. Burrows stated he was unaware of any new maps, and Ms. Delamare does not speak for him, as the developer. Mr. Burrows stated MBC Holdings, the Mall at Turtle Creek, and retailers have done what they said they would do, and contended it is wrong for the Administration to put them in this position.

Mr. Burrows stated MBC Holdings was blackmailed by the City of Jonesboro into doing a drainage project behind Kohl's. He stated they built the project according to the drainage plan that met code and had been approved by the City of Jonesboro, but at the end of the project were threatened with not being issued a certificate of occupancy unless they did as instructed on the engineering work. He stated they either spent \$400,000 (plus) to comply with the City's demands or be exposed for several million more. He stated an alderman questioned the then city engineer, if he was applying a different standard to this project than the current rules and regulations. Mr. Burrow stated they would let the courts decide if the city engineer told the truth, but they had built the project according to the existing code, and not some future regulations. He reported is was the intent of MBC Holdings to take this matter to court and let a neutral party decide if they built according to code and did what they said they would do.

Mr. Burrows stated this will effect future growth because lending institutions will not loan money if the threat of not getting a certificate of occupancy is based on somebody changing the rules. He stated the retail community is small and will not build because they are fearful that their plans will not get approved,. He contended this will cost the City of Jonesboro jobs and money. Mr. Burrow pointing his fingers in opposite directions, questioned who is on first, stating everybody is declaring it is somebody elses responsibility. Mr. Burrows requested the City Council consider adopting an ordinance that would prevent certificate of occupancy denial, giving developers or homeowners no recourse but to compy, and fight it out after the fact.

In closing, Mr. Burrow stated it is wrong not to inform individuals south of the mall that a large number of the structures have been designated by FEMA as being out of the flood plain, based on something that may happen in the future.

Mayor Formon responded saying he had met with Dan Pierce a few weeks ago, and while MBC Holdings has done what it said it would do, it is the responsibility of the homeowner to find out wether or not they are in the flood plain. He stated they have flood maps available, and one on display in the lobby of city hall. Mayor Formon explained they have been asked repeatedly to send out a letter stating individuals have been taken out of the flood plain, but that can not be determined. He stated it is the homeowners responsibility

to contact their mortgage company to find out what steps they need to take. He stated calls coming into City Hall regarding this matter are referred to Mr. Teddy Hooton, Flood Plain Administrator. He further stated a determination can not be made from the maps, that they must obtain an elevation certificate which is up to their mortgage company.

Councilperson Tim McCall stated the problem is lack of communication. Mayor Formon responded saying the Public Works Department has discussed the CTP project could possibly over-ride the LOMR, and he did not want someone going through the steps of dropping their flood insurance only to be put back in the flood plain. Mayor Formon further stated he had spoken with Mr. Dan Pierce, and from those conversations it was his understanding that MBC Holdings wanted a letter to be sent telling individuals they were out of the flood plain. He also explained he had mistakenly thought Mr. Bernie Auld had sent a letter telling individuals they had been removed from the flood plain, but later discovered that was not the case.

Discussion followed regarding the completion date of the CTP Project ranging from a couple of months to a year. Councilwoman Furr agreed with Mr. Burrow's statement saying, there is a lack of communication. Ms. Furr stated she had no confidence in Ms. Delamare, a representative of FEMA, explaining the night Ms. Delamare addressed the Jonesboro City Council, she left the meeting and asked Ms. Furr what TV station was local, because Ms. Delamare wanted to see how much trouble she was in. Councilwoman Furr stated that did nothing to inspire confidence in anything she said, relating to the Kohl's issue.

At the request of Councilman Dover, Mr. Mike Cameron spoke saying the Flood Plain Administrator at the time stopped the Corp of Engineers from proceeding with a project that would have removed, residents from the flood plain two and half years ago. Mr. Cameron stated Mr. Burrows in doing the LOMR and the nine acre detention pond improved the area and brought more structures out of the flood plain. Mr. Cameron also stated someone has the unofficial CTP maps because he has seen pictures of them.

Mr. Dan Pierce, referring to the meeting Mayor Formon spoke about earlier, stated they had offered to mail out letters, but did not get a response from the Mayor's staff. He also stated they suggested a press conference notifying the public that the maps are available, but were denied because of the pending CTP maps. Mr. Pierce stated if it takes a year for the CTP project, and even if it puts someone back in the flood plain, they will have saved a year's worth of insurance.

Councilperson Charles Frierson moved, seconded by Councilperson Tim McCall that a letter be drafted informing the public that the maps are available, and to contact their insurance company. Mayor Formon requested the City Attorney draft the letter making sure it is correct and not misleading.

8. Mayor's Reports

Mayor Formon provided a report from Clarke Mosquito Control, stating certain softball games and the Hollywood Theater had to be shut down due to mosquitos. He stated Clarke Mosquito Control had informed him they were inexperienced with mosquito abatement in rice fields, but would be doing aerial spraying starting tomorrow. He stated they were trying to develop a plan for cleaning the ditches and to prioritize them. Councilman Hargis stated individuals were contacting him about these projects, to which Mayor Formon requested Councilman Hargis have them contact the Public Works Department.
