Parks Director Jason Wilkie explained the agreement outlines the guidelines for Parks to put the race on for KAIT and in return get \$12,000 worth of advertising for Parks to be used however they want. He further explained the race will be April 19th in Craighead Forest Park and last until noon. Councilman Hargis questioned how much the race would cost. Mr. Wilkie stated the race would cost approximately \$12,000 in vehicles, fuel, personnel and other expenses. He added there is some room for them to make money. Chairman Frierson noted the City has performed the service for the race in the past, but the City is now getting advertising in return.

Mr. Wilkie explained the grant is 100% and there will be no cost to the City. He further explained the money will be used for signal flashers for the schools and for sidewalks at Hillcrest and West Elementary School. Councilman Hargis questioned whether the schools apply for the grants as well. Mr. Tony Thomas answered no, not in our area; rather, they are working in coordination with the City. Mr. Wilkie explained they felt they will receive a stronger grant if the schools and community work together.

Councilman Province stated there are a lot of damaged stones in the cemeteries. He added the families deserve better up-keep for what's out there. Chairman Frierson questioned whether that was the City's responsibility. Councilman Province explained about a year ago he watched some of the people mowing the lawn and they weren't very careful around the stones. He asked for whoever will be mowing the cemeteries to be more careful around the grave stones. Mr. Wilkie explained last year the same crew that took care of the urban parks also took care of the cemeteries, so they fell behind and probably weren't very careful. He added this year they're going to have a crew take care of just urban parks and another crew take care of cemeteries. He stated hopefully

there will be an improvement.

Maps of Craighead Forest Park

Councilman Hargis stated he would like to see overhead maps of Craighead Forest Park because not everyone utilizes all of the resources. Mr. Wilkie stated he has an aerial photograph that he can show to Councilman Hargis if needed. Councilman Hargis questioned whether the map can be made available to the public. Mr. Wilkie answered yes, they can do that.
