ORDER OF CONFIRMATION OF ANNEXATION

Now on this date hereinafter set forth comes on for hearing before the Court the above-styled cause and matter now appearing for the approval and confirmation of the annexation of said lands heretofore annexed to the City of Jonesboro, Arkansas, by Order of this Court dated December 30, 1985, and filed of record January 9, 1986. The Petitioners appear by and through their attorney, Curt Huckaby. The matter is heard upon the pleadings and order with exhibits thereto, filed herein, the Certificate of the Circuit Court of Craighead County, Arkansas, Western District, certifying that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County to prevent the annexation of said land and territory herein, from all of which together with other things and matters before the Court, the Court doth find as follows:

1. That said lands herein were annexed to the City of Jonesboro, Arkansas, by Order of this Court dated December 30, 1985, and that no proceedings have been filed in the Circuit Court of Craighead County, Jonesboro District, Arkansas, to prevent said annexation within thirty (30) days from the date of said Order and annexation and that said annexation was in all things done in conformity with the laws of the Statutes of the State of Arkansas and therefore, should be approved and confirmed; that said territory should be accepted by the City of Jonesboro, Arkansas.

2. That the lands and territory annexed to the City of Jonesboro, Arkansas, are described as follows, to-wit:

A part of the Southeast Quarter of the Northwest Quarter of Section 36, Township 14 North, Range 3 East, described as follows: Beginning at the Northwest Corner of said Southeast Quarter of the Northwest Quarter of Section 36, thence East 437.6 feet, thence South 458 feet to center of Highway No. 39, thence Southwesterly along center of said Highway, 110 feet; thence Northwesterly 422 feet to a point 481.4 feet South of point of beginning, thence North to point of beginning, containing 6 acres, more or less.

IT IS, THEREFORE, BY THE COURT, CONSIDERED, ORDERED AND ADJUDGED, that the annexation of said lands and territory herein to the City of Jonesboro, Arkansas, be and all things approved and confirmed and the proceedings before this Court be and are hereby confirmed. The Clerk of the Court be and is hereby authorized and directed to certify one copy of the Plat of such annexed territory with one copy of this Order of the County Court and the Resolution to the City of Jonesboro, Arkansas, and forward copies of each to the Secretary of State who shall file and preserve the same and shall forward one copy of the Plat of said annexed territory and one copy of this Order to the Director of the Tax Division of the Arkansas Public Service Commission shall file and preserve the same and shall notify all utility companies having property in said municipality of this annexation of property and the Clerk is directed to forward a certified copy of this Order to the City of Jonesboro, Arkansas.
