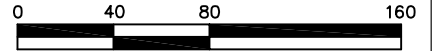







GRID NORTH
BASED ON GPS OBSERVATION



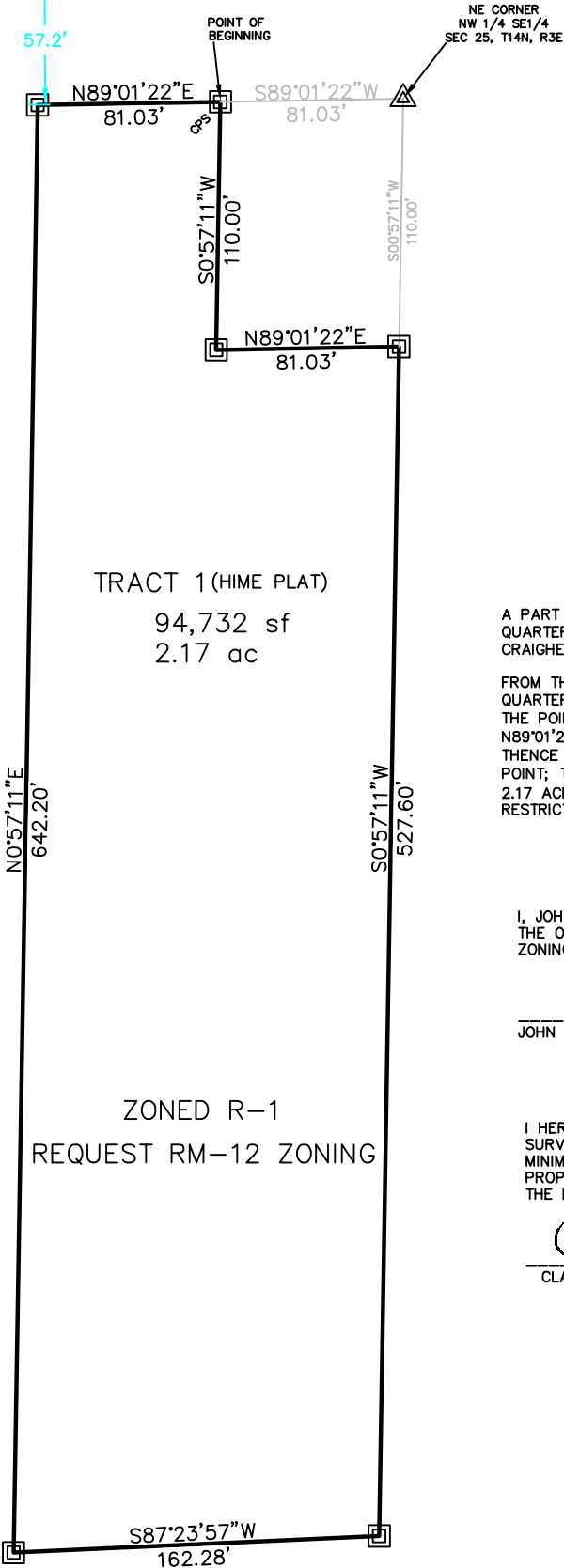

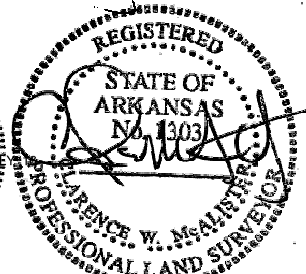
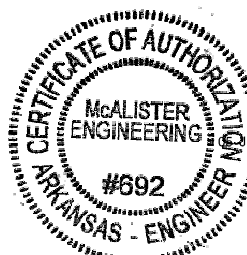
