Mr. Pat Alston spoke in opposition to the resolution. He asked the Council to suspend the public safety tax. He explained the City has made \$5.6 million on the tax. He asked what would stop the mayor from abusing the merit raises. He stated the Mayor indicated he represents the City employees, but who represents the taxpayers.

Councilman Fears asked about the process. He clarified the department head will make the recommendation, the Mayor will approve it and then it will go to the Finance Committee for approval. Mayor Perrin answered no, the merit increases will be approved in his office and will not be presented to a Council committee. The increase will then be sent to the Finance Department to be implemented. He explained

employees will qualify for an increase based on outstanding job performance or for certifications. Department heads will submit the employee's last evaluation and the certification or training obtained. The certification or training has to be directly related to the employee's job. He will also consider why the department head says the employee has done an exceptional job and should get a merit increase. Once that is finished, he will send it to the Finance Department. He further explained they have set aside \$75,000 for 2014. At any time, the City Council can amend or terminate the merit increases. Mayor Perrin also added there is a maximum increase of 25% of the base salary.

Councilman Street stated he has reservations about merit increases, but trusts the Mayor's judgment and leadership so he will approve it. He stated there is some room for abuse, but thinks the Mayor will be fair. Mayor Perrin added any merit increases that are given will be reported to the Council.

Councilman McCall explained he has struggled with this and has voiced his concerns with the Mayor, but the added information in the resolution made him feel better. He noted all of the employees will still receive cost of living increases. Mayor Perrin agreed, noting they amended the resolution to reflect that the cost of living increases will not be affected by the merit increases.

Councilman Fears questioned if the Mayor will inform the Council of any merit increases. Mayor Perrin answered yes, he will give the Council all of the documentation he received to make his determination as well as what was done with the merit increase.

Councilman Johnson also stated this has been a struggle for him because he thinks it will be one-sided. He added he will trust the Mayor to make the right decision.

Mayor Perrin thanked the Council for their trust in him. He explained they will be conservative with the merit increases. He added if, at any time, the Council does not agree with the decisions made they can amend or terminate the merit increase plan.

Councilman Fears stated the City has great employees and there are some who are probably underpaid and need more than a cost of living increase.

## 8. MAYOR'S REPORTS

Bids for Fire Station #5 came in lower than expected. Construction Network received the bid.

At the last Highway Department meeting, they were able to get a minute order to study the Highway 351/Highway 41 project. They received another \$4.8 million in funds to do overlays starting at the overpass on Highway 49 and going for 2 miles.

The bid was awarded to Asphalt Producers.

He commended the Street and Sanitation Departments for their work during the recent ice storms. He thanked them for their hard work.

City Engineer Craig Light has set up a meeting with the Corps of Engineers for January 22, 2014, to discuss what the next step is.

Arkansas Fire Prevention Code changes will start on January 1.

City employee Lorenzo Baldaras will be calling each of the Council members to set up times to do new interviews for Channel 24.

The Highway Department approved the transfer of the leftover funds for the walking trail project from Allen Park to Main Street. The remaining funds will be used to build a new bike and walk trail in Craighead Forest. It won't be enough to go all the way around the lake, but they plan to ask for more funding to complete the trail in the future. This will make a 12-foot wide surface around the lake.
