## **Caraway Road Railroad Overpass**

- AHTD study identified several alternatives; Estimated costs were \$2 to \$3 million for an overpass and approximately \$10 million for railroad track consolidation.
- AHTD has committed \$1.5 million and the City and ASU have each committed \$750,000 to the work.
- The job is included in the 1999-2001 STIP as an "illustrative" project that will be advanced if special funds become available.
- ASU has received \$600,000 in Scenic Byway funds and \$200,000 in Transportation and Community System Preservation (TCSP) funds for project development.
  Both of these programs require a 20% non-federal match.
- In order to expedite project development, ASU will obtain the services of a consultant for environmental handling and preparation of construction plans.
- AHTD will administer the funds and assure compliance with all FHWA procedures.

Thank you for sending us the Agreement of Understanding between Arkansas State University and the Arkansas State Highway and Transportation Department for the Caraway Road Safety Enhancement Project.

Our Board of Trustees will consider the resolution you provided at its May 12, 2000 meeting. We believe the resolution to be straightforward and will forward a signed copy to you once approved.

Most importantly, we appreciate the collaborative effort that is being undertaken on this particular project. The Arkansas State Highway and Transportation Department's verbal commitment in the amount of \$1.5 million, as well as the City of Jonesboro's verbal commitment of \$750,000 only proves the need and support of this important endeavor. Our largest benefactor remains the Federal Government, but we feel confident that our legislative representatives are working hard to make this happen.
