Chaudry, Nasir vs. Phillips Investments, et al. Case No. CV-2005-799 (DB) This case involves declaratory judgment and injunctive action issues.

Bill Cope vs. Jonesboro, et al.

Craighead Co. Circuit No.

CV-2003-1-H

This is another zoning case in which the Plaintiff's request for certain property to be re-zoned from residential to commercial was denied.

Harvey Edwards vs. City of Jonesboro Craighead Co. Circuit No. CV-2005-385-F This case alleges negligent operation of the landfill and permitting combustible gases to escape onto property.

Trial was held on March 29<sup>th</sup> and 30<sup>th</sup>, 2007.
