*Mr. Huffstetler explained the promoter of this event will charge for people to attend the event, but the promoter for the fireworks at Southside Softball Complex will not charge. He added the promoter for the fireworks at Southside Softball Complex asked that the contract state they will not be charging anyone who attends their event. He noted he spoke with Assistant City Attorney Carol Duncan and she said that the City cannot control what the promoter charges for admission.*

*Mayor Perrin stated the City needs to review this in the near future concerning the price. Mr. Huffstetler explained he wanted a contract to cover the City in case the fireworks catch Craighead Forest Park on fire.*

*Mayor Perrin explained the City needs to figure out if the \$1,500 is fair for renting the entire facility for a day, while shutting down a public facility and then charging for admission to the park. Mr. Huffstetler stated that the event is paid for by the money collected from the public attending the event, unlike the firework event at Southside Softball Complex which is paid for by sponsors.*

*Mayor Perrin noted he would like to see one big firework event instead of 3 different ones.*

*Councilman Frierson stated he does not think it is right to charge the citizens for entrance to a public facility.*

##### Concession stand at Southside Softball Complex

*Mayor Perrin explained that the concession stand at the Southside Softball Complex is under construction and they have 90 days to complete construction. He added he will be visiting some baseball fields in Mississippi and Tennessee to see how they compare to Jonesboro's baseball/softball fields.*

*Discussion was held concerning projects that could be done at Southside and Joe Mack Campbell Park.*

*Councilman Frierson inquired if the City manages the concession stands. Mayor Perrin answered the City does not manage the concession stands at Joe Mack Campbell Park. He noted the contract with the Jonesboro Booster Club expires this year, but the City is currently looking at whether the City should manage the concession stands or continue allowing the Booster Club to manage them.*

##### Allen Park

*Mayor Perrin explained the City is moving the dirt from the detention pond by the Turtle Creek Mall to Allen Park so it will be more level and will then be a football practice field.*

##### Craighead Forest Park

*Mr. Huffstetler discussed the work being done on the bridge from Access 5 to Fort Rotary.*

*Mayor Perrin stated a bathroom facility was supposed to be built there but that hasn't happened yet. He added Mr. Tom Beasley with the Rotary Club is going to be making a payment and the City will be extending the note for the Rotary Clubs. Discussion was then held concerning the note with the Rotary Club.*

*Councilman Frierson asked if the income for JETS has increased since an article was done about JETS coordinating with other agencies. Transit Coordinator Steve Ewart answered no. Discussion was then held concerning the coordinating efforts.*
