Councilmember David McClain stated to Chairman Joe Hafner that he had a question, and to please correct him if he was wrong. Councilmember McClain said that we have applied for something like this before. Is this the second time we weren't successful in getting it. Mayor Harold Perrin said no. This is the TAP Grant that we apply for every year and we have gotten a little over a million dollars for this project already. Mayor Perrin explain that we were applying again. Their share would be \$355,516, and our share would be \$88,879, which is the eighty twenty match. This would all go towards that connectivity between Arkansas State University and downtown Jonesboro. Councilmember McClain said okay. So, this is in addition to money we already have. Mayor Harold Perrin said, that is correct. We have earmarked the money that we have been getting just for that project. Chairman Joe Hafner stated like Mayor Perrin said we already have some money devoted to this project. I think it will be really neat when this project is actually done.

Patti Lack, 4108 Forrest Hill Road has a question. Mayor Perrin said let me first ask if Finance Director Steve Purtee is connected to the ZOOM meeting. Chairman Joe Hafner asked what the question was. Mayor Harold Perrin said the question from Patti Lack is how much has been raised for this project?

Mayor Harold Perrin said the answer that I would give you Patti is, well over a million dollars. I can't tell you the exact amount to the penny. Mayor Perrin was informed that Finance Director, Steve Purtee had joined the meeting. Mayor Perrin asked Mr. Purtee on the ASU connectivity project with the TAP Grants we've calculated over the last two to three years, plus others, what do we have in that account now?

Finance Director Steve Purtee said yes, with grant proceeds that we are expecting, we are anticipating additional grant funds of just under a million dollars. Mayor Harold

Perrin said so, it is close to a million dollars before we get this? Mr. Purtee said that is correct. So, to answer the question from Patti Lack we are close to a million dollars now, and of course we will be applying for this grant which will put us over a million dollars. Chairman Joe Hafner asked if that answered Mrs. Lack's question. Chief of Staff Mike Downing said yes.

7. Public Comments

Nick Wysocki, 107 Harvester Drive, Jonesboro, AR. Wanted to know if someone could comment on how we are continuing to pay for the Shooting Sports Complex. Chairman Joe Hafner stated that Mayor Harold Perrin just stepped out, and I'm not sure if Finance Director Steve Purtee wants to make a comment on this. Chairman Hafner stated that there was money budgeted for this. I'm sure that is part of the projects they are looking at, and how to move forward, and continue to fund that project. Obviously with the grant money that was received, and money that was budgeted for the first 4 ½ months of this year, that is what has been spent. But, I am not sure of the year-to-date number.

Finance Director, Steve Purtee said to Chairman Joe Hafner, Our budget for 2020 included an expenditure in Capital Improvement of \$2,250,000. Thus far, through April 30, 2020, we have spent approximately \$400,000. The majority of that is going to the contractor for the construction project as well as architectural fees. That is where we are today. Chairman Hafner asked, if part of the review would be looking at how to curb spending for the remainder of the year. Finance Director, Steve Purtee said that we have conducted two meetings thus far, to discuss what approaches that can be determined to hold the construction dollars below contract, and also consider any alternative sources of funds relative to sponsorship.

Chairman Joe Havfner said another thing that has happened because of COVID19 is the Shooting Range Advisory Committee has not gotten to meet like Mayor Perrin had hoped it would. I know one of the things that committee was going to look at was private funding. Councilmember LJ Bryant said Mr. Chairman if I could ask Finance Director Steve Purtee something since we are talking about it. Are we on track with Game and Fish to be where we need to be by the required dead line? Mr. Purtee said yes. It is anticipated by the end of June the baffling will be sufficient to accommodate pistol and rifle shooting.

Mayor Harold Perrin said, Mr. Chairman we met today. Chairman Joe Hafner is correct,

it has been slow because of the COVID19. That committee will be calling a ZOOM meeting on that. I'm sure to get a lot of people together like that is difficult. There was some talk of them maybe trying to have it out at the Embassy Convention Center. A prior Game and Fish Commissioner who lives here in town, and is also on the committee he gave us an update. I thought it was extremely positive, he will be coming up here I hope within the next two weeks to work with us, and we will start immediately going out and speaking to private investors to go out there. I have talked to a few people who has a deep interest in investing in the Shooting Range.
