PETITION FOR ANNEXATION

1. The undersigned petitioners represent a majority of the total number of real estate owners and own more than one-half of the following described real property located in Craighead County, Arkansas:

A part of Section 9, Township 14 North, Range 3 East, being more particularly described as follows: Begin at the Northwest Corner of Section 9, Township 14 North, Range 3 East; thence South on the Section Line to the Northwest Corner of the Southwest Quarter of the Northwest Quarter of said Section 9, the point of beginning proper; thence East on the 40 acre line to the centerline of the Saint Louis/San Francisco (Burlington/Northern) Railroad; thence southeasterly with the meanderings with said railroad centerline to a point 300.00 feet North (measured at right angles) of the centerline of U.S. Highway No. 63-B; thence West parallel to and 300.00 feet from the centerline of U.S. Highway No. 63-B to the intersection with a line parallel to and 300.00 feet West (measured at right angles) from the centerline of U.S. Highway No. 63; thence Southeasterly parallel to and 300.00 feet from the centerline of U.S. Highway No. 63 to the South line of the North Half of the Southwest Quarter of said Section 9; thence West on the 40 acre line to the West line of said Section 9; thence North on the Section line to the Northwest Corner of the Southwest Quarter of the Northwest Quarter of said Section 9; the point of beginning proper, containing 149.4 acres, more or less, subject to all rights of way and easement of record.

2. The above described property is contiguous to and adjoins the city limits of Jonesboro, Craighead County,

Arkansas, and should be annexed thereto. Donn Mixon, attorney at law, is hereby named as the person authorized to act on behalf of the petitioners.

WHEREFORE, petitioners pray that this court enter an Order fixing a date, time and place for hearing on said Petition for Annexation; that notice thereof be published as provided for in Ark. Code Ann. § 14-40-602; and that, at such hearing, the court make the necessary orders annexing said above described lands to the City of Jonesboro, Arkansas.
