


CERTIFICATE OF SURVEY:

A PART OF THE SOUTH HALF OF THE NORTHWEST QUARTER OF SECTION 32, TOWNSHIP 14 NORTH, RANGE 4 EAST CRAIGHEAD COUNTY, ARKANSAS BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGIN AT THE NORTHWEST CORNER OF LOT 18 MEDALLION ACRES SECOND ADDITION TO THE CITY OF JONESBORO, ARKANSAS; THENCE NOO'58'30"W — 50.66'; THENCE NOO'49'40"W — 120.00' TO THE SOUTH RIGHT OF WAY LINE OF MEDALLION CIRCLE; THENCE IN A SOUTHEASTERLY DIRECTION ALONG A CURVE TO THE RIGHT (R=90.71') — 71.25' TO THE POINT OF TANGENT; THENCE S45'50'24"E ALONG SAID RIGHT OF WAY LINE — 140.80' TO A POINT OF CURVETURE TO THE LEFT; THENCE SOUTHEASTERLY ALONG SAID CURVE (R=150.71') — 48.20'; THENCE S00'49'40"E — 16.78' TO THE NORTH LINE OF MEDALLION ACRES SECOND ADDITION; THENCE S89'20'1"W — 13.03'; THENCE S89'13'18"W — 99.52' TO THE POINT OF BEGINNING CONTAINING 0.48 ACRES MORE OR LESS SUBJECT TO ALL RIGHTS OF WAY AND EASEMENTS OF RECORD.
