Mr. Ewart stated the old fire station has been removed and they are in the process of having the debris removed, but JETS needs a temporary home until the new building is finished. He added the City is able to lease part of the parking lot at East Gate Plaza and were able to obtain liability insurance.

Councilman Moore questioned how long JETS anticipates using this piece of property. Mr. Ewart answered from November 1, 2014, to approximately August 1, 2015.

Councilman Moore then asked if it is just temporary. Mr. Ewart answered yes. He stated they will be putting 3 shelters on the property and running 5 buses from this location.

Councilman Street inquired if the City would be able to extend the lease if the new building is not complete. Mr. Ewart answered yes.
