Ordinances To Be Introduced

ORD-09:028

AN ORDINANCE TO AUTHORIZE THE CITY OF JONESBORO TO USE RESERVE FUND BALANCES TO FINANCE THE COST OR RELATED COST OF THE ICE STORM, TO APPROPRIATE THE NECESSARY FUNDS, TO EXTEND THE CONTRACT TIME FRAME TO COMPLETE DEBRIS DISPOSAL, AND FOR OTHER PURPOSES

Sponsors: Public Works

Mayor Perrin explained the original contract with D&J has expired and this ordinance will extend it to August 7. He further explained money that was already spent on the debris contract has been paid from unallocated reserves and they expect the City will have to pay \$200,363 after being reimbursed by the government. He added they're looking into ways to get the \$200,363 reimbursed as well.

A motion was made by Councilman Darrel Dover, seconded by Councilman John Street, that this matter be Recommended to Council . The motion PASSED by an unanimous vote

Councilman Dover motioned, seconded by Councilman Street, to move the regular monthly meeting to the second Tuesday of the month at 4:00 p.m. All voted aye.
