Councilman Street stated they don't want to see the departments go back to the landfill and that the relocation is just temporary. He added the Public Works Committee supports the construction of a shop building for Streets, Sanitation and the police division on the Edwards property the City just acquired. He asked the City Clerk to poll the Council in order to set up a special called meeting with the only business being what direction the City will go towards regarding long range facilities. He noted it's a Council decision, so the whole Council should weigh in on it. Councilman Street stated due to the Planning Department being moved to the Council Conference Room all committee meetings will have to take place in Council Chambers. Councilman Hargis questioned whether there is an itemized list to detail how the \$60,000 will be spent. City Engineer Craig Light stated \$30,000 will be spent on the Strawfloor site, bringing it back up to service with things such as the septic system and the air conditioning. He explained approximately \$5,000 will be spent to get the offices in the Huntington Building set up for the Planning Department. He further explained the rest would be for the lease amount in the JETS facility. Mayor Formon asked Mr. Light to send a list to the Council members detailing what the \$60,000 is being used for.

Councilman Street announced a Stormwater Board meeting on October 15, 2008, at 8:30 a.m.

Councilman Johnson noted the Public Works Committee did not take the relocation issue lightly and discussed it at length. Mayor Formon noted the methane gas is not an issue at the landfill anymore.

Councilman McCall asked for someone to look at Murray Creek off Crepe Myrtle and Murray Creek Road. He explained he has received complaints about erosion in those areas.

Councilman Moore asked for an update concerning the traffic light on the corner of Main Street and Cherry. Public Works Director Erick Woodruff stated they ordered a new arm for the light due to it being struck when a nearby tree fell. He stated it will be 4-7 weeks.

Councilman Moore then asked for an update regarding security at the fair. Police Chief Michael Yates explained they put extra measures in place this year and made the mobile force available if needed. He further explained dress requirements and behaviors were more stringent this year than in the past. He stated they got positive feedback and had fewer issues this year. Councilman Moore stated the Jonesboro Sun alluded to some gang activity at the fair on Saturday night. Councilman Johnson, a member of the fair committee, said this was the smoothest year for the fair than ever. He added he didn't remember seeing a single incident and didn't have any problems.

Councilman Moore questioned the crime statistics that were reported in the Sun. Chief Yates explained he is not familiar with what was reported in the Sun, but he sent a report into the Sun today with crime statistics in it. He discussed the report sent to the Sun. Councilman Moore asked for Chief Yates to email the statistics to him. Councilman Moore questioned how they can compare the statistics for Jonesboro to other cities such as Little Rock. Chief Yates stated he doesn't think there's an easy way to compare the cities. He directed Councilman Moore to homestore.com, a real estate site, where users can compare statistics by zip codes, which is a reflection of what is going on in those areas. He stated it's not the best, but is the quickest and easiest way to get a picture. Councilman Moore asked Chief Yates to make a presentation towards the end of the year concerning crime statistics and compare the statistics to two or three other large cities in Arkansas.

Mr. Dan Melton stated he's had a booth at the fair almost every year since 1978. He explained this year was the finest, most orderly fair he's participated in.

Councilman Hargis explained he would like an aggregated overview of the finances.

He further explained he gets different answers concerning revenues. He stated the current report shows \$29.497 million in revenues, which is better than a lot of other communities. He noted according to the \$29.497 revenues the City would take in about \$44 million in revenues for the year, which is surprisingly small. Mr. Barksdale stated the report is for the first eight months of the year and did not segregate grant revenue or other sources of revenue. He explained they are working on issues to straighten the information out. He further explained part of the problem is the lack of written processes.

Councilman Province agreed with Councilman Johnson regarding the move to the landfill, stating the Public Works Committee wanted assurances this would be a temporary move. He stated he hopes it can be taken care of quickly.
