*Councilmember John Street said, "Walk it on to tonight's agenda." Councilmember David McClain said, "Chief, I believe, was about to speak on this." Police Chief Rick Elliott approached the podium, "Mr. Chair, if you would like a little bit of explanation on this, I'll be glad to provide with so. As you know there is a vehicle shortage across the country and over the past year we've had approximately 12 vehicles totaled out over the course of our duties daily and right now I have around 20 vehicles slated to be decommissioned, hopefully in January, and I have 60 vehicles with over 100,000 miles on them. Our fleet is aged, we've had some losses. We've gained the insurance money from these losses that will kind of help offset some of this expense but as we look on the state contract and try to find replacement vehicles, they're not available. I did find a vender in Oklahoma that happened to get some in and they're a little less than \$2,000 more than the actual state bid of Arkansas, but the fact that they're on lot and I can take immediate possession, we found this is desirable. The Tahoe's are going to the canine units, which that fleet of 2014 is aging and already experiencing mechanical problems. Again, these vehicles are on lot, they're on hold for us, they're ready to up fit them and get them sent to Jonesboro as soon as we get this contract approved and moved forward. So I am asking that you look at the contract, move it forward to full council if you would please. We did ask for the emergency clause, because again, this is time sensitive, that again this dealer has got a hold on these and we are just trying to move forward on this project. If not they will have to take the hold off and somebody else across the country will pick up the vehicles then we will be in the same boat. We're already having concerns about vehicle purchases for next year due to the shortages. We may be in a bigger crunch then. As we find these vehicles that kind of pop up, between now and the end of the year, if I can find more vehicles we may be back in the same boat as tonight. Just kind of heads up, we're needing about 23-25 vehicles to get caught back up on our rotation at some point in time. If we can spread that out it would be great but again, finding the vehicles is the first problem. This is kind of the first step but I would say, if I can find more vehicles then I will approach the Mayor and see if we can do an additional midyear purchases, if it does come up."*

*Patti Lack, 4108 Forrest Hill Road, approached the podium, "Chief Elliott, I can probably get you one more vehicle and that is because, if you guys remember, a couple of years ago Chief Elliot and Mayor Perrin switched vehicles. I know that back on June 11th I wrote and I got a memo back from Bill Campbell and it was talking about the vehicle that Mayor Perrin had, that he had switched. That it wasn't as well equipped as the one they switched with and I asked where is and what's it doing. There were a couple of people that had questions about it and I was told that it is in the fleet of the city cars right now. It's being used by staff people with Mayor Copenhaver's discretion here. So the 2 questions I want to ask you guys, because we can get him one more car. Does this justify this car sitting here in the parking lot and paying the insurance when being used every once in a while or can we have the police*

department use it on a regular basis and use it all the time and is it the best use for our citizens money by just sitting here? So that car was good for Chief Elliot a couple of years ago and it's just sitting here in the parking lot." Chairman Joe Hafner said, "Patti, I don't believe Chief Elliott ever drove the Mayor's car." Patti Lack said, "They switched if I remember correctly." Chairman Joe Hafner said, "No, that car was purchased from a dealership." Chief Rick Elliott approached the podium, "Back when this transaction was made, Mayor Perrin had a Suburban vehicle that he traded into Cavanaugh for a brand new police packaged Tahoe and fully equipped and it was an even trade. No money. In fact, during that transaction, we saved the tax payers about \$12,000 because Mayor Perrin passed the Tahoe to the Police Department, which I'm currently assigned to that vehicle and ended up picking up this Infinity that's currently assigned to the Mayor's office right now. So the question about the Infinity, that is assigned to the Mayor's office and the Tahoe that you speak of is assigned to me and was the day this transaction took place. The Infinity is not a vehicle I would put out on the streets for patrol. It could be utilized in another capacity but the vehicles we're talking about tonight are for patrol type used vehicles. That's the history on that transaction, again, the key point on that, which a lot of people have trouble understanding, at the time we saved money. We saved almost \$12,000 during that transaction that year, even though people didn't understand the Mayor was getting a different vehicle, its taxpayer's dollars we saved. It's not one budget verses another budget, bottom line is, it all comes out of the taxpayers' dollars." Chairman Joe Hafner said, "Right, and you never drove the Infinity." Chief Rick Elliott said, "I never drove the Infinity." Chairman Joe Hafner said, "That was never part of the Police Department." Chief Rick Elliott said, "I never had a use for the Infinity. Obviously it does not suit my needs. My vehicle serves as a mobile command post, like during the tornado. I need a large vehicle and I carry a large amount of equipment. This Infinity is not in question tonight by any means." Patti Lack said, "Well then, I just want to add a comment to that then. I guess that's what we assumed, that it was equipped because the Chief was driving it." Chairman Joe Hafner said, "But he never drove the Infinity." Patti Lack said, "Ok then, I guess I don't understand the trade on that. I'll pass on that one there. The other thing I just wanted to say is, I don't have a problem with the purchasing of the vehicles and I understand that there is an emergency clause. The other thing that I want to add is, since this is a special called meeting and it was supposed to happen last week is that I hope I can request all of you that all the rest of the agenda items that are on the Finance Committee be moved to the City Council meeting that is on the 8th so that people will have the time to look at it and have the time and not just a couple of hours between the next meeting.
