Comes now the undersigned petitioners, and for their Petition, state:

1. Petitioners own land which abuts an alley running north from Johnson Avenue mid-way of block 15 of the Matthews addition for a distance of three hundred feet and intersecting an alley running east and west between drake and fisher street.
