WITNESSETH:

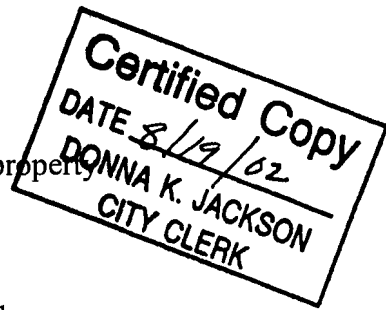
The party of the first part is the owner of certain property at 1401 Brookhaven Road, Jonesboro, Arkansas, Parcel Number 88.

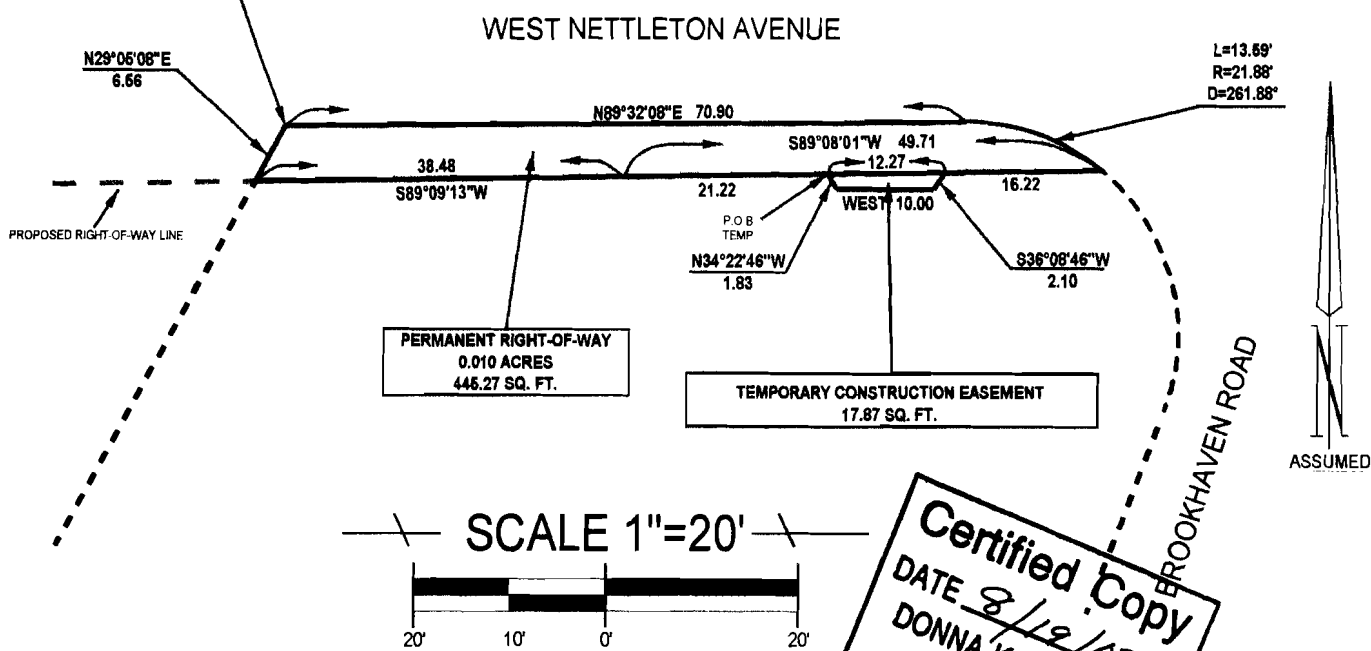

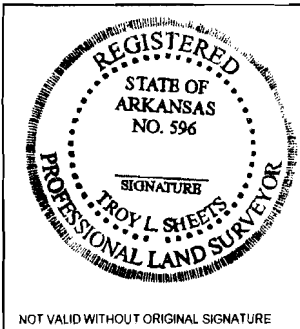

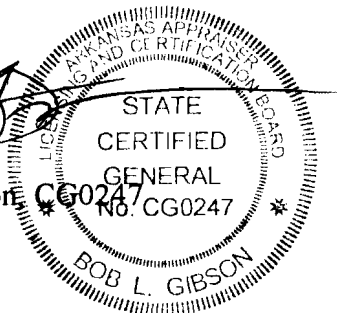
Dear Mr. Scott:

I have appraised the above property as of February 26, 2002, and find the market value to be \$16,720. In accordance with your instructions, I have reduced the lot size by the "amount of taking" for the purpose of widening Nettleton Avenue. The remaining value is \$16,008 or a difference of \$712 which is the just compensation due the owner. In addition, a temporary easement in the amount of 17.87 sq ft is being used. A fee of \$150 is paid for this inconvenience bringing total compensation to \$862.

The purpose of this appraisal is to give a fair market value of the land taken by the City of Jonesboro for the expansion of Nettleton Avenue. The subject at 1401 Brookhaven Rd will lose a tract of land: 445.27 sq ft

The value of the improvements has not been affected. Therefore, the assessed value of the improvements has not been used in the appraisal. The set back should not affect the driveway and the entrance to the improvements.
