Public Works Director Erick Woodruff explained this contract is the same that had been presented to the City Council before. He stated the contract was reviewed by the Fire & Police Chiefs. He noted he was appointed to be the contract manager after the contract is approved by Council.

Chief Yates explained both he and the Fire Chief had reviewed the contract, but no one on staff is an expert in the operation and technical aspects of the tornado sirens. He added a vendor who did not get awarded the contract had concerns over the technical elements in the low bidder's contract. He stated he had a person from Emergency Management, who has expertise in this matter, go over the low bid and they found no reason not to go with the low bidder. Chairman Moore questioned if the low bidder had explained to the Council everything was included in the specs. Chief Yates answered yes.

Councilman Harold Perrin stated he would like for all contracts to have a project manager who would report back to administration and Council concerning the project status. He added he named Mr. Woodruff to be the project manager for the tornado sirens contract.

Chairman Moore stated he would take this resolution to Council tonight.

Employee Representative Larry Jackson suggested putting one of the old tornado sirens in the Craighead Forest Park campground. Chairman Moore stated the tornado sirens contract requires the City to be fully covered, but if the new sirens coverage is insufficient in the campground they could possibly put an old tornado siren in the campground.

A motion was made by Councilman Harold Perrin, seconded by Councilman Mitch Johnson, that this matter be Recommended to Council . The motion PASSED by an unanimous vote
