Right-of-Way

Whereas, Jonesboro YMCA, Incorporated, is the owner of land in Craighead County, Arkansas described below, and the City of Jonesboro, a municipal corporation of the State of Arkansas, is the owner of adjoining land;

Whereas, Jonesboro YMCA, Incorporated, and city have agreed upon a right-of-way for construction and maintenance of a street across the land of Jonesboro YMCA, Incorporated, in favor of <u>city</u> and in favor of the land of city.

1. Jonesboro YMCA, Incorporated, in consideration of the agreement hereinafter made by city, grants to city a right-of-way for construction and maintenance of a street over the land Jonesboro YMCA, Incorporated, in City of Jonesboro, Craighead County, Arkansas, or particularly described as follows:

DESCRIPTION OF TEMPORARY CONSTRUCTION EASEMENT

PART OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 24, TOWNSHIP 14 NORTH, RANGE 3 EAST, CRAIGHEAD COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGIN AT THE NORTHEAST CORNER OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 24, TOWNSHIP 14 NORTH, RANGE 3 EAST, CRAIGHEAD COUNTY, ARKANSAS; THENCE SOUTH 89°24'08" WEST, ALONG THE NORTH LINE OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 24 AFORESAID, 27.00 FEET; THENCE SOUTH 0°46'08" WEST 36.00 FEET; THENCE SOUTH 89°24'08" EAST 11.56 FEET TO THE POINT OF BEGINNING PROPER; THENCE SOUTH 14°19'18" WEST 0.74 FEET; THENCE SOUTH 89°06'17" WEST 44.01 FEET; THENCE NORTH 1°28'43" EAST 0.94 FEET; THENCE NORTH 89°24'08" EAST 44.16 FEET TO THE POINT OF BEGINNING PROPER, CONTAINED, 0.001 ACRES, (36.43 SQUARE FEET).



2. Jonesboro YMCA, Incorporated, warrants the right-of-way against anyone claiming it or in any manner preventing free and unobstructed use of it by city.

City, in consideration of the grant of right-of-way aforesaid, agrees to construct, 3. maintain and improve the property through the use as is set forth herein.

4. This agreement shall inure to and bind the heirs, executors, administrators, successors and assigns of the parties and shall constitute a covenant running with the land of Jonesboro YMCA, Incorporated.
