8. MAYOR'S REPORTS

Mayor Harold Copenhaver reported on the following:

Of course, Christmas at the Park drive thru is two weeks into a fabulous season. I want to thank our Parks staff, our Downtown Jonesboro Alliance and all of the generous volunteers who make all of these events possible. The joy of the season is truly being felt in Jonesboro in December these days. Activities downtown are open through 8:30 p.m. on weeknights through Christmas and until 9:30 p.m. on Friday and Saturday.

I attended another wonderful event and touching parade last week at the Human Development Center with a lot of kind volunteers. Our Police and Fire Departments and charitable organizations worked with resource center leadership to make a special parade for the center's residents. Their hearts touched all of our hearts.

If you haven't finished your shopping, by the way, most of haven't, remember the value of shopping local. Our business owners in town are a key part of what makes our community so special. Let's support them together. Here is one of the examples of why we need to support local businesses. I would like to thank the wonderful folks at Hijinx. They donated pallets full of cleaning products to Animal Control, who just

passed a milestone of 2,000 volunteer hours from community members this year. Speaking of Christmas presents, we still have more animals than we can service at Animal Control. So, go see if we have that perfect addition for your family just in time for the holiday season.

I was invited to light the Christmas tree at St. Bernards last week and I want to take a moment to remember all who are ill and their loved ones at their sides at this time of year. Of course, we can't express enough of our appreciation for our first responders, hospital staff, and everyone working to serve others at this time. Your work is priceless.

The Mayor's City Youth Advisory Council hosted their Christmas party this weekend and thank you to those who came by and for the joy and the festivities and the staff that took time out of their day to come meet with these wonderful young men and women. And, I must say that we had a first floor full of families, parents, grandparents all supporting their youth as they continue to learn about our community.

We achieved another landmark with a groundbreaking yesterday of a bike trail that will connect Arkansas State University to downtown. Like the fiber partnership with Ritter, we announced this last month. This has been a priority since my administration took office. It takes time to acquire rights-of-way and make the trail shovel ready. But, all of that is done now and I am eager to get more trail going through our city.

Our early roll-off dumpster cleanups have proven successful. Code Enforcement, Sanitation, JPD, and Street Departments will continue these as long as they are productive in helping people clean up their homes and their yards. This past weekend, we filled up two roll-off dumpsters with a knuckleboom and disposed of more than 40 tires during a setup at Fox Meadow Elementary. We will announce the next dates locally. I might add to that, that was in a four hour timeframe.

As you may have heard, we were successful in landing a sizeable grant for the police safety equipment from the State of Arkansas. This comes at a great time of need. This is a \$100,000 grant that will be used to further the growing technology emphasis in public safety.

This morning, our friends at First Security Bank, helped us surprise one of our newest employee of the month. Congratulations go to Assistant City Attorney Heather Owens. I think she was truly surprised. She has seen her workload increase dramatically and as the District Court demands have grown as well. So, I want to say thank you to Heather for all the hard work she has done and we look forward to getting her some more help soon.

One more significant act of kindness and partnership, I want to mention took part last week. U.S. Congressman Rick Crawford stopped by office and we visited for quite a while. He gave the City of Jonesboro a flag that was flown over the U.S. Capitol. I want to say thank you to our Congressman for his continued services to Jonesboro.

9. CITY COUNCIL REPORTS

Councilmember John Street said, I don't know if you were aware that City Water and Light got a \$5 million grant to use towards wastewater treatment. That was an excellent grant that benefits every citizen in Jonesboro. That money will go towards making all of our utilities a little bit cheaper. So, congratulations to the staff and grant writers at CWL for that. Mayor Copenhagen said, I would also like to add to that the importance of City Water and Light. As we adopted the trail yesterday, they have

already started moving the utility poles and without that behind the scenes, people don't see that, but we certainly appreciate it.

Councilmember LJ Bryant said, I will just make a brief comment. I know the Mayor has wanted us to email in our questions and I have emailed some questions about eight days ago that I haven't heard back on. So, if we could just kind of work on the communication between us and your folks, that would be great. Mayor Copenhaver said, we have got them ready. They are on my desk. Councilmember Bryant said, okay, thank you.

Councilmember Joe Hafner said, we have a working session to go through the budget on Friday beginning at 2:30 p.m. here in council chambers. No action will be taken at that meeting. It will just be a question and answer information session. Obviously, the Finance Committee is going to be kind of the ones there, but anybody on the council that wants to come is more than welcome to come. Like I said, no action will be taken. It is just more of an information session to learn about the Mayor's budget and asking a few questions and comments and stuff.

Councilmember David McClain said, one thing, tonight is still election day. And, for anyone that has not voted, you still have time to vote until 7:30 p.m.

Councilmember Ann Williams said, I wanted to check and see if there was any update on the RFQ for the Impact Fees Study. We had a new RFQ being drafted I think. Mayor Copenhaver said, Ann, I will get that back to you. I am not aware of the update at this point, but I will get back with you first thing in the morning. Councilmember Williams asked, we are getting an updated RFQ right? Mayor Copenhaver said, yes. Councilmember Williams asked, have we heard anything from ARDOT about the pedestrian crossing at State Street? Mayor Copenhaver stated, no ma'am, not at this point. We were in conversations with them two weeks ago when we had that and as you well know, it takes a little bit of lengthy time with Brad. Councilmember Williams said, oh, I know. Mayor Copenhaver said, Brad was actually in my office this past week with discussion of many projects that we are working on, but yes, that is on the agenda. Councilmember Williams said, okay, good deal.

Councilmember Chris Moore said, I just wanted to echo the Mayor's comments. I was downtown at the Christmas Parade and at Joy Fest. It was quite a crowd. I think the parade may have been the largest that we have had in several years. Downtown was looking good. Lights were all up and people were excited. Mayor Copenhaver said, it was good. Councilmember Moore said, the only thing that I wanted to mention that we might look into is at the corner of Washington and Union, the street lights didn't work from there down towards the Shadrach's Coffee. It was awful dark in that area. So, if you don't mind, have City Water and Light check that out. Mayor Copenhaver said, okay, absolutely, yes sir. Councilmember Moore said, thank you Mayor. Mayor Copenhaver said, thank you.

Councilmember Brian Emison said, I just had two things that I wanted to bring up. I want to echo Councilmember McClain that you have until 7:30 p.m. to go out and vote tonight and the closest precinct to you right now is the Earl Bell Community Center. It is down there on Church. So, swing by on your way home if you haven't voted yet. The only other thing that I have is that recently I was contacted by a citizen that lives out in Barrington Park. They had said with some new construction that had gone on at the intersection of Weldon Lane and Annadale Drive, that there has been some increased traffic there and they thought that a stop sign might help. There has been a couple of almost accidents there in the last week or so. So, if we could look into that, I would appreciate it. Mayor Copenhaver said, thank you Councilman.

10. PUBLIC COMMENTS

Jason Rufkhar, 710 W. Cherry, said, I live right down the street from the Public Library. Where I live is directly across the street from CWL Park and I mean directly across the street from City Water and Light Park. The topic I want to touch on tonight is the park sits here and my apartment sits here and there is always kids and adults over there playing basketball. And, just here recently, the Parks and Rec Department went over there and put in two, like, one of them is like an exercise type equipment thing, and the other was a jungle gym type of thing. And, they are directly right there by the road. When they did that, they peeled back the green fencing. Before they did that, I thought they were putting up a JETS bus stop. That is what me and my neighbor lady thought. So, I went over there and talked to him when he was over there and I asked him what are you doing and he told me what they were doing. But, when they had the fenced peeled back, I asked him because it was a Parks and Recreation guy, is there a way that you can take this fence and you can extend it all the way down to the road and maybe bring the other one up there. And, I told him, here's why, because those kids get out there, I don't care what time of day it is, and they will play ball. I said, the next thing you know, the basketball hits the rim and shoots off into the road and here I come to the stop sign or wherever, it could be me or it could be anybody, and they start darting out in front of the road just like a dog and you don't see them. If you are paying attention to here or here, here comes somebody. This just happened before I came up here. I have got my eye on the road and here comes a guy in a white t-shirt out here chasing a ball and I had to slam on my brakes. So, what I want is for you to extend the fence to the road so that way it is kind of like a playground. You shoot the ball. It is there and it goes over here and stops at the fence. It is as simple as that and nobody has to worry about getting hit or anything like that. Mayor Copenhagen said, alright, well, Jason, thank you for your comments. We will look into it Jason. Thank you. Mr. Rufkhar said, because when I talked with the guy he said we would have to look for funding. And, I said, well, you can look for funding or you can look for a dead body on the road because people run up and down that street all of the time. There is actually tire marks from where they burn out and everything. I am just trying to be nice saving you guys from seeing somebody else get hit. Mayor Copenhagen stated, I hear what you are saying. Danny, would you like to add a few comments to that? I appreciate that Jason. Parks and Recreation Director Danny Kapales said, as always, my office is open if anybody wants to ask questions about Parks and about what activities we are doing there. We did peel that back to put in the workout equipment. If you will notice through that area, we actually have sleeves in the ground. We are going to extend the fence all the way down to the corner of the parking lot there. Mr. Rufkhar said, cool. Mr. Kapales said, this should stop the balls from going as far as the road. Mr. Rufkhar said, cool, problem solved. Mayor Copenhagen said, thanks Danny.
