CDBG Amendment Proposal – 2005/2006 Program June 28, 2007

The following is the proposed Amendment to the CDBG (Community Development Block Grant) Projected Use of Funds for Fiscal Years 2005, and 2006 of the United States Department of Housing and Urban Development (HUD).

All HUD projects are subject to federal regulations and requirements including that the appropriate amendments be filed with HUD whenever the City decides not to carry out an activity described, to carry out an activity not previously described, or to substantially change the purpose, scope, location or beneficiaries of an activity. Substantial changes are defined as those modifications involving amounts greater than 10 percent of the current year federal allocation. As a result of changes in various City procedures, and a change in the planning of several projects, it is desirous to propose changes in the funds and scope of the projects as set out below.

A citizen advisory committee meeting was held on May 1, 2007 and public hearings were held on May 31, 2007, June 27, 2007 to review the current projects and to suggest changes in our projects. The revisions were approved by the CDBG Citizen Advisory Committee and are hereby recommended for referral for the approval of the Mayor and City Council.

Currently, the projects herein identified are particularly affected by timeliness concerns. Based on the technical advice received by HUD stating that it would be in our best interest to reallocate unspent funds to areas that could be expended during this fiscal year, the Citizen Advisory Committee is making the attached requests to reallocate the unspent fund balances.

This amendment greatly assists in the elimination of the inherited backlog of projects. The City Council approval is imperative to assist the City in meeting the HUD required deadline.

It is desirous to close some projects and to change the program allocations and scope of various Community Development Projects for Jonesboro, Arkansas as follows:
