OCCUPATION OF ANNEXATION

On this 20th day of October, 1980, comes on for hearing before the Court the above styled cause and matter now appearing for approval and confirmation of the annexation of said lands heretofore annexed to the City of Jonesboro, Arkansas, by Order of this Court dated September 9, 1980.

The Petitioners appear by and through their attorney, Dennis Zolper.

The matter is heard upon the pleadings and orders with exhibits thereto filed herein, the certificate of the Circuit Court Clerk of Craighead County, Arkansas, certifying that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County, Arkansas to prevent the annexation of said lands and the territory herein, from all of which together with other things and matters before the Court, the Court doth find:

1. That said lands herein are annexed to the City of Jonesboro by Order of this Court dated September 9, 1980, and that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County, Arkansas, to prevent such annexation within thirty (30) days from the date of said Order and annexation, and that said annexation was all things done in penformance with the laws and statutes of the State of Arkansas, and should therefor be approved and confirmed; that said territory should be accepted by the City of Jonesboro, Arkansas; that the lands and territories annexed to the City of Jonesboro, Arkansas, described as follows, to-wit:

A part of the South ½ of the SW¼ of the NE¼ of Section 29, Township 14 North, Range 4 East, being more particularly described as follows: Begin at the Soothwest Corner of aforesaid SW¼ NE½; thence N89°02'E on the 40 acre line 50.0'; thence N0°11½'E 50.0' to the North R/W line of Race Street; thence N89°02'E along said R/W line 149.0'; thence S89°03'E along said R/W line 21.01' to the point of beginning proper; thence N0°11½'E 342.15'; thence S89°05'W 170.0' to the East R/W line of Browns Lane; thence N0°11½'E along said R/W line 60.0'; thence N89°05'E 160.0'; thence N0°11½'E 207.0' to the North line of said S½ SW¼ NE½; thence N89°05'E along the 20 acre line 519.65'; thence S0°11½'W 625.74' to the North R/W line of Race Street; thence N89°03'W along said R/W line 509.30' to the point of beginning proper, containing 7.50 acres.

IT IS THEREFORE BY THE COURT, CONSIDERED, ORDERED AND ADJUDGED that the annexation of said lands and territories herein to the City of Jonesboro, Arkansas, be and in all things approved and confirmed, and that the proceedings before this Court be and are hereby confirmed. The Clerk of this Court be and is hereby authorised and directed to certify one copy of the Plat of such annexed territory with one copy of this Order of the County Court and resolution or ordinance of the City of Jonesboro, Arkansas, and forward a copy of each to the Secretary of State who shall file and preserve the same and shall forward one copy of the Plat of said annexed territory and one copy of this Order to the Director of the Tax Division of the Arkansas Public Service Commission who shall file and preserve the same and shall notify all utility company having property in said municipality of this annexation of property, and the Clerk is directed to forward a certified copy of this Order to the City Clerk's office for the City of Jonesboro, Arkansas.
