## PETITION TO VACATE AND ABANDON A PORTION OF PETE LANE, A/K/A MEAD DRIVE

Western District of Craighead County, Arkansas. A copy of the plat is attached hereto and labeled Exhibit "A".

- 4. That the portion of the street described herein to be vacated and abandoned also abuts the North end of lot 24 of Pine Hills Subdivision. The record plat of Pine Hills Subdivision is filed in Plat Deed Record Book 123 at page 34, in the Office of the Circuit Clerk and Ex-officio Recorder of the Western District of Craighead County, Arkansas. A copy of the plat is attached hereto and labeled Exhibit "B".

That the petitioners request the City Council, by resolution, direct the City Clerk to give notice by publication once a week for two (2) weeks in the <u>Jonesboro Sun</u> advising property owners affected that on a day certain the City Council for the City of Jonesboro, Arkansas, will hear this petition and determine whether such portion of Pete Lane, a/k/a Mead Drive, should be vacated and abandoned.
