

TO THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS

IN THE MATTER OF CLOSING OF A PORTION OF GORDON STREET BEGINNING 140 FEET WEST OF ITS INTERSECTION WITH FOURTH STREET AND CONTINUING WEST UNTIL ITS INTERSECTION WITH McCLURE STREET AND A PORTION OF WORD STREET BETWEEN FOURTH STREET AND McCLURE.

## PETITION TO VACATE AND ABANDON PORTIONS OF TWO STREETS

Come the undersigned Petitioners, by and through their attorneys, and for their Petition state:

1. Petitioners own all the land which abuts Gordon Street beginning 140 feet west of its intersection with Fourth Street and continuing west until its intersection with McClure Street and a portion of Word Street between Fourth and McClure in the City of Jonesboro.

2. Said portion of Gordon Street has been dedicated as a public street to the City of Jonesboro, Arkansas, but has never been developed as a street and is not needed for highway purposes and the safety of its citizens and the welfare of the City will be enhanced or promoted by the abandonment of said street.

3. Said portion of Word Street has been dedicated as a public street to the City of Jonesboro, Arkansas, and has been developed as a street but is not needed for highway purposes and the safety of its citizens and the welfare of the City will be enhanced or promoted by the abandonment of said street.

4. Petitioners request that the City of Jonesboro by and through its City Council abandon and vacate a portion of Gordon Street beginning 140 feet west of its intersection with Fourth Street and continuing west until its intersection with McClure Street and a portion of Word Street between Fourth Street and McClure Street located in the City of Jonesboro, Arkansas. 5. Petitioners request that the City Council by resolution direct the City Clerk to give notice by publication once a week for two weeks in The Jonesboro Sun advising property owners who might be affected that on a day certain the City Council for the City of Jonesboro will hear this Petition and determine whether such public streets should be abandoned and vacated.

This Petition is hereby presented and filed with the City Clerk for the City of Jonesboro, Arkansas, pursuant to Arkansas Code Annotated Title 14-301-306 and 14-54-104.
