ORDER OF CONFIRMATION OF ANNEXATION

On this Stay of September, 1981, comes on for hearing before the Court the above styled cause and matter now appearing for the approval and confirmation of the annexation of said lands heretofore annexed to the City of Jonesboro, Arkansas, by Order of this Court dated August 10, 1981. The Petitioners appear by and through their attorney, David Rees. The matter is heard upon pleadings and orders with exhibits thereto filed herein, the certificate of the Circuit Court Clerk of Craighead County, Arkansas, certifying that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County to prevent the annexation of said lands and the territory herein, from all of which, together with other things and matters before the Court, the Court doth find:

That said lands herein are annexed to the City of Jonesboro by Order of this Court dated August 10, 1981, and that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County, Arkansas, to prevent such annexation within thirty (30) days from the date of said Order and annexation, and that said annexation was in all things done in conforming with the laws and statutes of the State of Arkansas and should therefore be approved and confirmed; that said territory should be accepted by the City of Jonesboro, Arkansas; that the lands and territories annexed to the City of Jonesboro, Arkansas, as described as follows, to-wit:

IT IS THEREFORE, BY THE COURT, CONSIDERED, ORDERED AND ADJUDGED that the annexation of said lands and territory herein to the City of Jonesboro, Arkansas, be and in all things approved and confirmed, and that the
