AN ORDINANCE DETERMINING THAT THE COST OF ACQUIRING SHIELDED LIGHTING FIXTURES IS PROHIBITIVE

Traffic Engineer Mark Nichols explained the existing act requires shielding on light fixtures. Most of the light fixtures in the city are non-shielded. Shielded lighting requires more fixtures on the roadway because one shielded fixture puts off less light than the non-shielded fixtures. Shielded lighting has no up light and only directs light downward. Mr. Nichols further explained the law does allow for cities to declare shielded lighting to be cost prohibitive and continue using non-shielded lighting. He added when they do the lighting for the roundabout they will be able to reduce the number of poles, fixtures, foundations, wiring, etc., by going with non-shielded fixtures.

Mayor Perrin explained Engineering has been looking at infrastructure projects for about the last two years that amount to over \$200 million. Fisher & Arnold will look at the projects, make a cost estimate for the projects as well as options for cash flow and how the projects can be paid for. They will also work with the city to hold public

hearings if the city has to hold any.

Councilman Dover stated this is in preparation for potentially asking the voters for a tax to complete the projects. Mayor Perrin answered yes.

Councilman Moore asked why this item needs to be walked on to the Council agenda tonight rather than be placed on the next agenda. Mayor Perrin stated this work needs to be done before a special election can be held. Even if this ordinance is passed tonight he thinks it'll be at least September before they can proceed with starting the process for a special election.

Mayor Perrin explained the current firing range is located in Craighead Forest Park. But, with the construction of homes in that area they have been looking at relocating the firing range. They propose a land swap with City Water & Light. The city will trade a portion of the parking lot next to the Municipal Center to CWL for 25 acres CWL owns that is located next to the city's Public Works facility on Dan Avenue.

Mayor Perrin discussed the proposed firing range. He noted the city will need to rezone the property to I-1. He also added they anticipate using the property for concealed weapon courses. There will be no exchange of cash, so the exchange will not cost the city anything.

Councilman Moore asked if the firing range will be open to the public on certain days. Police Chief Rick Elliott answered yes, they will open the firing range to the public at certain times because there is a need for the general public to participate in shooting sports. They are also looking at putting a skeet range and trap range on the property. They hope to have the shooting portion open by spring and the buildings open as the budget allows. Police Chief Elliott noted several shooting clubs and other companies have already spoken with him about donating to the project.

Mayor Perrin added he will be meeting with the Game & Fish Commission to see if the city can get some funding to help finance the project. Councilman Moore noted the Game & Fish Commission was supposed to open a firing range in Black Rock, but couldn't due to financial concerns. So, they may want to partner with the city on the project.
