Police Chief Michael Yates explained there is a provision in State law that allows municipalities and counties to add a \$5.00 fee with traffic tickets and fines to defray jail cost. He added the County had passed an Ordinance to add an extra fee to tickets and fines about 3 years ago. He also added in the Attorney General's opinion the City should do the same. He noted the extra fee could bring in approximately \$75,000 to \$90,000 a year.
